On 17 April 2019, Indonesians marched to the polls to elect their president and vice president directly for the fourth time since 2004. The main contenders for the presidency—Joko "Jokowi" Widodo and Prabowo Subianto—were the same as when they first clashed in 2014, and the result was the same. Some of the issues raised in 2014 were rehashed in 2019, and the geographical polarization of voters had deepened along the same fault lines. Indonesia under Suharto had attempted to become a regional power to lead Southeast Asian states and beyond. As the largest country and also the richest in terms of natural resources, Suharto's Indonesia was held in deference by the ASEAN states. However, due to its limited capabilities, its lack of military strength, advanced technology and economic strength, the political influence of Jakarta was in fact quite limited. During the economic crisis, Suharto was



forced to step down. He was succeeded by B.J. Habibie who was largely preoccupied with domestic issues, who in turn was followed by weak presidencies such as Abdurrahman Wahid (Gus Dur) and Megawati. Only after the ex-general Susilo Bambang Yudhoyono assumed presidency did he manage to stabilize the situation and attained economic growth. He even became known as the "Foreign Policy President".

Its membership was restricted to graduates of British and European universities, fellows of British or European learned societies and those with "distinguished merit in the opinion of the Society in any branch

of knowledge". Its closed-door meetings were an important gathering place for the educated elite of the colony, comprising colonial civil servants, soldiers, missionaries, businessmen, as well as prominent Straits Chinese members. Notable members included the botanist Henry Ridley, the missionary W.G. Shellabear and Straits Chinese reformers like Lim Boon Keng and Tan Teck Soon.

On 16 June 2021 the National Heritage Board announced the successful conclusion of the archaeological excavation of two shipwrecks at the eastern approach to Singapore. This book documents the two shipwrecks and their findings, complemented by essays on Singapore's larger maritime history through time, from Temasek in the 14th century through the emergence of country trade to the late 18th century. Beyond the finds recovered from the bosom of the sea, the positioning of the shipwreck in the contexts of the past challenges us to rethink Singapore's history as a globally entangled one, determined by what was happening on the seas in and around the island.

Can Malaysia Eliminate Forced Labour by 2030?

Forced labour, encompassing various types of coercive practices and rights violations, is an entrenched problem in Malaysia. Recent years have seen more decisive and concerted efforts to resolve the problem and repair Malaysia's damaged reputation, but the country's forced labour woes escalated amid COVID-19, with exposés and trade embargoes in 2020–21.

Most consequentially, the US has imposed withhold release orders (WROs) on major rubber glove manufacturers and palm oil producers. For two consecutive years, 2021–22, Malaysia has occupied the lowest Tier 3 in the US Trafficking in Persons report. In November 2021, the country's National Action Plan on Forced Labour (NAPFL), formulated through tripartite engagements with the participation of the International Labour Organization, was launched, with the third National Action Plan on Trafficking in Persons (NAPTIP 3.0) operating in tandem.

ISEAS – Yusof Ishak Institute has commissioned a second nationwide survey in Indonesia as a follow-up to the first similar project in 2017 called the Indonesia National Survey Project (INSP). Its broad aim is to enhance understanding of political, economic, and social developments in Indonesia. Its key findings are as follows:

- The approval rating of President Joko Widodo hovers around 71.8 per cent, at least before the September 2022 announcement on the fuel subsidy cut. His major infrastructure push as his flagship development programme still garners the most positive assessment. However, poverty, unemployment and cost of living remain key flashpoints that the government should be concerned with.
- While respondents are generally aware of the plan to relocate the national capital and are more
 likely to agree rather than disagree with it, most have reservations about its urgency and the financial
 burden that such an undertaking implies.

GVC Reconfiguration: Risks and Opportunities for ASEAN Members

The COVID-19 pandemic, geopolitical tensions and US-China trade disputes, and the Russia-Ukraine war have increased the risk of global value chain (GVC) disruptions and forced firms to strengthen resilience in their supply chains and operations.

MNCs have diversified suppliers, established new production sites, and shifted production closer to consumers. ASEAN countries are becoming increasingly attractive destinations for foreign investors.

This paper gauges the position of ASEAN in GVCs and assesses the risks and opportunities of GVC reconfiguration for ASEAN countries. ASEAN countries are increasing their participation in GVCs and raising domestic value-added. The relocation of production sites from China to ASEAN countries could enhance their participation in GVCs. Should MNCs increase the concentration of supplier and buyer markets, ASEAN countries could become more vulnerable to external shocks.

Tides of Insecurity: Vietnam and the Growing Challenge from Non-traditional Maritime Threats

While the South China Sea dispute remains Vietnam's top security concern, the country also confronts a variety of growing non-traditional threats, such as illegal fishing, maritime violence, smuggling, ecological degradation and climate change.



These issues adversely affect Vietnam's external relations, socio-economic development, marine ecosystems and political stability, while engendering and exacerbating regional tensions.

In response, at the national level, Vietnam has focused on building a blue economy and strengthening its law enforcement capacity.

At the international level, Vietnam has participated in a variety of bilateral and multilateral cooperative mechanisms. However, these efforts have been impeded by internal and external factors, such as corruption, inadequate capacity and lack of budget, as well as ASEAN's institutional limitations and sovereignty sensitivities.

Rhizome vs Regime: Southeast Asia's Digitally Mediated Youth Movements

In Indonesia, Thailand and Myanmar, democratic regression and the reconsolidation of authoritarian regimes have triggered the rise of social media-driven protest movements. These are pioneered by a new generation of activist youth, distinguishing themselves from previous student and youth movements by the digitally mediated, decentralized and diverse nature of their protest.



While experimenting with digitally mediated repertoires of action adopted and adapted from similar struggles elsewhere, these protesters forge transnational links that give rise to new protest assemblages across and beyond the region. This is exemplified by the social media-based #MilkTeaAlliance, in which the distinct protests in Indonesia, Thailand, Myanmar and other countries are conjoined through extended solidarity and affinity ties in a common "generational" struggle against entrenched authoritarianism. The youth resistance in Hong Kong was instrumental in driving this trend.

Young Hearts and Minds: Understanding Malaysian Gen Z's Political Perspectives and Allegiances

The 15th general election (GE15) in Malaysia produced surprising results. The conservative coalition of PN emerged as the dark horse of the election, overtaking the longest-ruling coalition, BN, by a significant margin. The two largest coalitions post-GE15, PH and PN, represent ideological opposites, which may spell a polarized future for Malaysian youths. This paper intends to understand what happened to the youth votes and provide possible hypotheses for future trends.



In West Malaysia, constituencies with a larger share of young voters (under 30 years old) registered a higher voter turnout rate. A majority of seats with 30 per cent or more of voters under 30 years old (considered "young" seats) were won by PN, followed by PH, and thirdly BN. This demonstrated PN's relatively stronger hold on young seats in GE15. Discrepancies between pre-GE15 survey findings and actual results could be explained by the Shy PN factor—or PN-leaning voters' reticence towards revealing their preference—and a swing from BN to PN.

The ASEAN+6 Single Window (ASW+6) in this study refers to the geographic expansion of the ASEAN Single Window (ASW) to enable cross-border electronic exchange of trade-related data and documents among ASEAN

member states and six FTA partners, namely, Australia, China, India, Japan, New Zealand and South Korea. The ASW is part of ASEAN's trade facilitation reform to reduce intraregional trade costs and time.

This study considers cross-border paperless trade measures to represent the implementation of ASW+6, using data from the UN Global Survey on Digital and Sustainable Trade Facilitation in 2019. The simulation analyses reveal that the ASW+6 has significant potential to reduce times required to export and import, and to boost trade in ASEAN and its FTA partners.


SME Responses to Climate Change in Southeast Asia

Micro-, small- and medium-sized enterprises (SMEs) account for approximately 97 per cent of all active business entities within the ASEAN region. They are an important contributor to both emissions generation and future reduction.

A recent large-scale, multi-country quantitative assessment was undertaken into how SMEs are dealing with climate change in Indonesia, Malaysia, the Philippines, Singapore and Vietnam. Most respondents reported a high level of concern about climate change.

Communicating COVID-19 Effectively in Malaysia: Challenges and Recommendations

Malaysia was initially lauded for its ability to combat the first few waves of COVID-19 but infection spikes since the Sabah state elections in September 2020 and subsequent exponential increases in both infections and deaths in 2021 left the nation reeling. Nationwide vaccination is seen as the only way out of the pandemic.

Malaysia's COVID-19 communication strategy was hampered by political machinations and myriad changes in government. The need to shore up favour

among the electorate resulted in inconsistent messaging and regular U-turns whenever there was public outrage at arbitrary restrictions. This resulted in confusion on the ground, preventing successful COVID-19 management and containment.

Under the current regime, claims to more accessible data have been disputed and doubts have surfaced over data transparency and accuracy. There is an urgent need to ensure convincingly reliable information, as well as to use more engaging messaging on more suitable media.

"Building a Sailboat in a Storm": The Evolution of COVAX in 2021 and Its Impact on Supplies to Southeast Asia's Six Lower-Income Economies

In the first half of 2021, COVID-19 vaccine doses from the COVAX Facility were in short supply, and the plan to mass produce COVAX vaccines through the Serum Institute of India (SII) faltered as the pandemic surged in India in March 2021.

Due to COVAX's shift in approach towards convincing richer nations to redistribute their excess doses, the second half of 2021 saw increases in the

frequency and volume of its shipments. Donors were however able to "earmark" their dose donations and identify their intended recipients.

The six Southeast Asian countries which qualified for free COVAX shots—Cambodia, Indonesia, Laos, the Philippines, Timor-Leste and Vietnam (the AMC6)—received 16 million doses in the first half of 2021. In the second half, they received 128 million doses from COVAX, 80.9 per cent of which were earmarked donations.

Despite making up 7 per cent of the world population, the AMC6 collectively accounted for 24.3 per cent of all earmarked dose donations (and 25 per cent of the United States' total dose donations) to COVAX in 2021.

A Study of Vietnam's Control over Online Anti-state Content

Over the past two decades, the fixation on anti-state content has shaped the way Vietnamese authorities deployed various censorship strategies to achieve the dual goals of creating a superficial openness while maintaining a tight grip on online discourses. These considerations dictated how several regulations on Internet controls were formulated and enforced.

Vietnamese censors also selectively borrowed from China's online censorship playbook, a key tenet of which is the fear-based approach. The

modus operandi for the authorities is to first harp on what they perceive as online foreign and domestic threats to Vietnam's social stability. Then those threats are exhaustively used to enforce tougher measures that are akin to those implemented in China.

But unlike China, Vietnam has not afforded to ban Western social media platforms altogether. Realizing that they would be better off exploiting social media for their own gains, Vietnamese authorities have sought to co-opt and utilize it to curb anti-state content on the Internet. The lure of the Vietnamese market has also emboldened Facebook and Google's YouTube to consider it fit to acquiesce to state censorship demands.

Religious extremism among students in major campuses in Indonesia remains a problem for the Indonesian government, campus authorities and moderate Muslims.


A substantial number of studies on Islam and religious extremism in Indonesia have focused on security and cultural paradigms. In contrast, this article discusses the factors that cause the rise of religious extremism among university students through an organizational and institutional lens.

The dissemination and internalization of religious extremist narratives contribute to the rise of religious extremism among university students in Indonesia.

Counter-extremism policies by the government and campus authorities have not been effective due to the absence of an integrative approach. All stakeholders—the government, campus authorities, parents of university students, communities and student organizations—need to establish a concerted and integrative effort to uproot religious extremism from among university students.

Cyber Troops, Online Manipulation of Public Opinion and Co-optation of Indonesia's Cybersphere

Organized propaganda and public opinion manipulation are increasing in Indonesia's cybersphere. Specifically, since 2019, there has been a marked rise

of cyber troop campaigns that serve to mobilize public consensus for controversial government policies.

Cyber troop operations played a crucial role in three controversial events in which public opinion had been initially critical of the government policy at issue. These were, first, the revision of the Law on the Corruption Eradication Commission in September 2019; second, the launch of the New Normal policy during the COVID-19 pandemic in May 2020; and third, the passing of the Omnibus Law for Job Creation in October 2020. In all three cases, there is clear evidence of cyber troops manipulating public opinion in support of government policy.

A few ASEAN countries have signed the Global Methane Pledge, but methane should receive a broader and higher priority from the entire region, given its significant contribution to climate change, and the availability of solutions.


The agriculture sector contributes the most amount of methane emissions with a steadily rising share over the past decade.

Several Southeast Asian countries face similar methane abatement challenges (i.e., agricultural productivity in Vietnam, Thailand, Myanmar and the Philippines; gas leakage in Malaysia and Brunei; and waste management in Indonesia, Malaysia and Singapore), warranting closer collaboration at the subregional level.

While it is true that countries have been participating in international initiatives and implementing national policies related to rice cultivation and oil and gas processing, their impacts have not been thoroughly evaluated.

Financial Technology Adoption in Greater Jakarta: Patterns, Constraints and Enablers

This article reports the findings of an online survey conducted in November–December 2021 on Indonesians' experience and perception of fintech tools,

focusing on fintech adoption in the Greater Jakarta region, which besides Jakarta, includes Bogor, Depok, Tangerang and Bekasi.

One key finding is that, in the Greater Jakarta region, socio-economic status as measured by income is not a key determinant of fintech adoption. This is likely due to the more developed and mature ICT infrastructure in the Greater Jakarta region, which makes fintech tools readily accessible.

However, the kinds of fintech tools that are more likely to be used—M-banking, E-wallet, Online Lending, Investment, Donations, and so on—are influenced by factors such as income, education, gender, age and occupation, suggesting that different fintech tools appeal to different groups in society according to their needs and resources.



Muslim Sectarianism versus the De-escalation of Sectarianism in Malaysia

In 1992, a group of academics at the National University of Malaysia (UKM) organized a seminar titled "Seminar Ahli Sunnah dan Syiah Imamiyyah" ("Seminar on Ahl al-Sunnah and Imami Shi'ism") in Kuala Lumpur. It aimed to demonize Shi'a Muslims and ban Shi'ism, effectively escalating sectarianism in Muslim society.

A Deobandi presenter at the seminar by the name of Muhammad Asri Yusoff put forth arguments about Shi'ism, which later became the "intellectual base" for the discrimination and repression of Shi'a Muslims by Islamic authorities in Malaysia. This repression continues till the present day, and other religious leaders—particularly those with a Salafi orientation—take part in this.

While much attention has been given to those who have escalated sectarianism, there have also been efforts to de-escalate sectarianism. These efforts come from groups such as Persatuan Ulama Malaysia, and individuals such as Abdul Hadi Awang of PAS, former Prime Minister Mahathir Mohamad, the leader of International Movement for a Just World, Chandra Muzaffar, as well as Malaysian academic, Syed Farid Alatas.

In the history of Indonesian Islam, although the issue of halalness, being an unseparated part of Islamic doctrine, is not new, it had never been the role of the state to formalize it into state law prior to the legislation of State Law No. 33/2014 on Halal Legal Assurance.

From the 1990s to 2014, halal matters including halal certification had been unofficially handled by the Council of Indonesian Ulama (MUI). Then, the Ministry of Religious Affairs (MORA) proposed that halal certification be officially handled by the government of Indonesia, not by Muslim organizations. The legislation of State Law No. 33/2014 reflects contestation between MUI and MORA regarding which institution should serve as the authority in certifying halal products.

Health Security in Indonesia and the Normalization of the Military's Non-Defence Role

Like many countries, Indonesia's armed forces (TNI) have been engaging in health security activities since the outbreak of the COVID-19 pandemic in March 2020. The pandemic has made TNI popular in society owing to its visible dedication to crisis response at the grassroots level. It is important to clarify how this became possible and the impact it has had from the perspective of civil-military relations.

TNI's widening and deepening involvement in health security is the product of the normalization of "military operations other than war" (MOOTW). The 2004 TNI law restricted non-defence missions and required that ad hoc arrangements to undertake such non-war emergency missions gain parliamentary approval. TNI has skilfully used patriotic propaganda to justify its COVID-19-linked activities by invoking the spirit of the war of independence. In doing so, military elites have stoked nationalist sentiments to blunt military reform measures and normalize their role expansion. This is a new development in the history of TNI's MOOTW; operations related to counter-terrorism and disaster relief in the past—for example, the 2018 natural disasters in Lombok and Palu—were limited in time and space. In this sense, the COVID-19 crisis should be understood as an important game changer in the country's post-authoritarian civil-military relations.

Thailand's Economic Dilemmas in Post-Pandemic Asia

While Thailand's health system has fared relatively well through the COVID-19 pandemic, the country's economy faced significant strains and likely a harsher downturn than other economies in Southeast Asia. In particular, the services sector—heavily reliant on international tourism—suffered, and debt levels worsened substantially during the pandemic.



Thailand's economy has steadily recovered following the peak of the pandemic in 2020, with greater optimism coming from the growing trade in goods and growing investments from China and Japan. The tourism sector has also steadily regained strength since the worst points of the pandemic.

Despite these recent positive turns, Thailand still faces daunting long-term economic and societal challenges, many of which were exacerbated by the COVID-19 pandemic. Household finances appear increasingly stressed and debt levels have risen sharply across the economy. It is unlikely that Thailand will be able to return its tourism industry to 2019 conditions for the next several years.

Concepts and Patterns of Chinese Migration, with Reference to Southeast Asia

Concepts and patterns of Chinese migration are often described with terms such as quigen (return to one's original roots), shenggen (sprout local roots), shigen (lose original roots), wugen (without roots), and duogen (many roots). These terms, linked to the Mandarin word *gen* (roots), carry various meanings including home, citizenship, ethnicity, as well as local language, culture and society.

In Southeast Asia, the predominant patterns of migration are shenggen/shigen, quigen, shenggen/ shigen, wugen and/or duogen. These concepts represent the mainstream patterns during various periods. which may admittedly exist concurrently.

The pattern in each particular period is influenced by an array of internal and external factors, such as colonial and subsequently government policies directed at migrants, as well as forces and opportunities afforded by globalization.

Explaining PAS's Dominance in Kelantan

The Islamic political party Pan-Malaysia Islamic Party (Parti Islam Se-Malaysia, PAS) has governed the state of Kelantan on the northeastern coast of peninsular Malaysia for most of Malaysia's post-independence history.

Until 2020, PAS functioned as an opposition party at the federal level, going against the government led by its long-time nemesis the politically stronger and better resourced United Malays National Organisation (UMNO). The David-versus-Goliath story has made PAS's longevity and durability in Kelantan all the more impressive for having endured decades of marginalization by

the federal government. This has to an extent led to the state's laggard developmental growth and poor socio-economic indicators.

PAS has often been portrayed by the mainstream media as an anachronistic and extremist party ill-equipped to cope with, much less solve, the myriad challenges faced by modern society.

Notwithstanding PAS's shortcomings, this article provides an analysis of the factors that have allowed the party to remain in power in Kelantan for so long. It argues that after winning back Kelantan from UMNO in 1990, PAS transformed itself into a modern, well-oiled political machine, particularly when it comes to socializing its agenda to the people of Kelantan and reaching out to many out-of-state Kelantan voters.

The Indonesian Military Enjoys Strong Public Trust and Support: Reasons and Implications

Opinion polls in Indonesia have repeatedly shown that the Indonesian National Army (TNI) is the state institution that enjoys the highest level of public trust. This is not something that is exclusive to Indonesia, however; according to several studies, people around the world place a higher level of trust in their military than they do in other institutions.



Even though there has been a surge of writing, both scholarly and non-scholarly, on this subject, there is a lack of information regarding the reasons why people put more faith in the military than in other institutions. Moreover, in Indonesia, public trust in the military has not been shaken despite the extensive anti-military campaigns that have been waged by the media and activists.

Consistent with previous works, the findings of my September 2021 survey indicate that the TNI has continued to enjoy the highest level of public trust among state institutions when compared to other political and social institutions. The respondents are also of the opinion that the military has been acting in the public's best interests.
