#### PREFACE

This book was stimulated by the aim of deepening comparison and dialogue between historical research on Northeast Asia and that on Southeast Asia. Two centres collaborated in the joint research project which provided the groundwork for the book. One was the Asia Research Institute at the National University of Singapore. The Institute's Southeast Asia-China Interactions Cluster brought together scholars working on Europeanlanguage, Chinese-language and Southeast Asian sources in an effort to understand the long-term relationships between China and her southern neighbours. The other was the Kaiiki Ajiashi Kenkyūkai – the Research Group of Maritime Asian History or Kaiikiken, established in 1993 and headquartered in Osaka, Japan. In cooperation with research groups on Central Asian history and early modern global history, the main axis for the activities of Kaiikiken's members was provided by the 21st Century Centre of Excellence Program "Interface Humanities" at Osaka University, 2003–7. Kaiikiken's principal research theme was the medieval and early modern maritime history of the area spanning Northeast and Southeast Asia. This work included exchange with scholars from Korea, China, Taiwan, and other regions. The Singapore and Osaka groups jointly hosted two international workshops: one in October 2004 in Okinawa titled "Northeast Asia in Maritime Perspective: A Dialogue with Southeast Asia" and one in Nagasaki in October 2006 titled "Dynamic Rimlands and Open Heartlands: Maritime Asia as a Site of Interactions". This book is a selection of papers presented at these workshops, all extensively revised for publication. A series of smaller panels and seminars were also held on related themes, including a session titled "the European Presence in Early-Modern East and Southeast Asia: Examination of the Concept of Early-Modern Empire" at the International Association of Historians of Asia (IAHA) conference in Taiwan in December 2004.

We are grateful for the support for these activities furnished by the Japan Society for the Promotion of Science (the 21st Century Centre of Excellence Program at Osaka University "Interface Humanities"), the Suntory Foundation ("A Theoretical Study of Continuity and Discontinuity in 'Early Modern' and 'Modern' East and Southeast Asia"), and the Asia Research Institute. The editors acknowledge a special debt to Geoff Wade of the Nalanda-Sriwijaya Centre (ISEAS), who was a critical part of the dialogue and infrastructure which enabled the conferences to take place, and again played an invaluable role preparing the book for publication. Deborah Chua of ARI was also very helpful in bringing some consistency to the usages of research papers coming from different traditions, and Joyce Zaide of ISEAS in formatting the manuscript and maps.

Because of the nature of this cooperative interaction, we have included Chinese, Japanese and Korean characters as well as Romanized names of authors and titles in the extensive combined bibliography. We hope that the book will thereby be of value to those working within both Asian language and European language traditions.

## CONTRIBUTORS

James K. CHIN, 鐵江, is a Research Fellow at the Centre of Asian Studies of the University of Hong Kong. His research interests include the maritime history of Asia, early Southeast Asia, and Chinese transnational migration and diaspora. He has published more than 60 journal articles and book chapters on these subjects.

**FUJITA Kayoko**,藤田加代子, is an Associate Professor at the Ritsumeikan Asia Pacific University (Beppu, Oita, Japan), where she teaches Japanese and global history. She studied the history of Japan's foreign relations at Osaka University (Japan) and Dutch commercial expansion to Asia at Leiden University (the Netherlands). Her research focuses on the changing patterns of intra-Asian and long-distance trade and their impacts on Japan's society and economy since the 16th century. She is co-editor with Geoff Wade of the forthcoming volume, *Empires and Networks: Maritime Asian Experiences — 9th to 19th Centuries*.

HASUDA Takashi, 蓮田隆志, is an Associate Professor at the East Asian Rim Research Center, Institute of Humanities, Social Science and Education, Niigata University. He obtained his doctorate in Asian History from Osaka University in 2006, where his main research interest was the political history of early modern Vietnam as well as international commerce and statecraft in maritime Asian history. He is currently working on internal politics and foreign relations of 17th-century Vietnam through an analysis of local documents.

**IIOKA Naoko** 飯岡直子, received her PhD from the National University of Singapore in 2009. She is interested in religion, commerce and diaspora in early modern maritime Asia.

LIU Shiuh-feng, 劉序楓, is an Associate Research Fellow at the Research Center for Humanities and Social Sciences, Academia Sinica, Taiwan. He specializes in Sino-Japanese relations and East Asian maritime history. In recent years his research interests have focused on the history of shipwrecks in East Asia, including China, Japan, Ryukyu and Korea.

**MOMOKI Shirō**, 桃木至朗, is Professor at Osaka University, Japan. He specializes in the history of medieval and early modern Vietnam and maritime Asia, and is now researching on the Thang Long Imperial Citadel (Hanoi) and its preservation. His publications include *The Formation and Transformation of the Medieval State of Dai Viet* (Osaka University Press, 2011, in Japanese); "Dai Viet and the South China Sea Trade from the 10th to the 15th Century", *Crossroads* 12, no. 1 (1999).

Anthony REID is a Southeast Asian historian, now again at the Australian National University after serving in turn as founding Director of the Center for Southeast Asian Studies at UCLA (1999–2002) and of the Asia Research Institute at the National University of Singapore (2002–7). His more recent and relevant books include *Southeast Asia in the Age of Commerce,* 1450–1680 (2 vols. 1988–93); An Indonesian Frontier: Acehnese and other Histories of Sumatra (2004); Imperial Alchemy: Nationalism and Political Identity in Southeast Asia (2010) and as (co-)editor, Negotiating Asymmetry: China's Place in Asia (2009); and the New Cambridge History of Islam, vol. 3 (2010).

**Kenneth R. ROBINSON** is a Special Visiting Scholar at the Northeast Asian History Foundation, in Seoul. His research focuses on Korean– Japanese relations in the fifteenth and sixteenth centuries and premodern Korean world maps and regional maps.

**SUN Laichen**, 孫來臣, received his PhD from the University of Michigan and is Associate Professor at California State University, Fullerton. His research interests includes Asian gunpowder technology and Sino-Southeast Asian interaction during the early modern era (c.1350–1800). His publications include *Southeast Asia in the Fifteenth Century: The China Factor* (co-editor with Geoff Wade), "Chinese Military Technology Transfers and the Emergence of Northern Mainland Southeast Asia, c.1390– 1527", "Chinese Gunpowder Technology and Dai Viet: c.1390-1497", and "Burmese Bells and Chinese Eroticism: Southeast Asia's Cultural Influence on China".

**Geoff WADE** is a historian currently attached to the Nalanda-Sriwijaya Centre (NSC), Institute of Southeast Asian Studies, Singapore after stints at the University of Hong Kong and the Asia Research Institute, National University of Singapore. He researches Sino-Southeast Asian historical interactions and comparative historiography, and has worked on a range of other related issues, including early Islam in Southeast Asia, Chinese expansions over time, Asian commercial networks, Chinese classical textual references to Southeast Asia, Australia's growing engagement with Asia, and the Cold War in Southeast Asia. His most recent edited work *China and Southeast Asia* (Routledge, 2009) comprises a six-volume survey of seminal works on Southeast Asia–China interactions over time. He also contributed the chapter on Islamic expansion in Southeast Asia (800–1500 CE) to the *New Cambridge History of Islam* (2010).

YAMAUCHI Shinji, 山内晋次, is Associate Professor at Kobe Woman's University, where he teaches ancient Japanese history and the history of pre-modern maritime Asia. His current research focuses on Japan's foreign relations from the 7th to the 14th centuries. His major publications include *Nara Heian-ki no Nihon to Ajia* [Japan and Asia during the Nara and Heian periods] (Tokyo: Yoshikawa Kōbunkan, 2003), *Nissō bōeki to "iō no michi"* [The Japan–Song trade and "the sulphur road"] and *Yamakawa Nihonshi Librétto* 75 (Tokyo: Yamakawa Shuppansha, 2009).
