**Charles Keyes** is Professor Emeritus of Anthropology and International Studies at the University of Washington. He has continuously conducted field-work in Thailand for five decades and published numerous books and articles on issues of religious, social, and economic change in Thailand. His monograph *Isan: Regionalism in Northeastern Thailand* (1967) ranks among the most influential works ever published on Thailand's Northeast. It appeared in Thai translation in 2009.

**Duncan McCargo** is Professor of Southeast Asian Politics at the University of Leeds and author of *Tearing Apart the Land: Islam and Legitimacy in Southern Thailand* (2008) and numerous other agenda-setting works on Thai politics.

**Michael J. Montesano** is a Visiting Research Fellow at the Institute of Southeast Asian Studies and a historian. He is the book review editor for the blog *New Mandala*, and a regular columnist on Southeast Asian affairs for the *Wall Street Journal Asia*.
