\* Chapter 4 is largely based on the author's paper "Trade Relations between Myanmar and Other Southeast Asian Countries" presented at the Conference on New Directions in Asian Studies held in Singapore during 1–3 February 1989.

1. Since June 1988 the name of the country has been changed from the "Union of Burma" to the "Union of Myanmar". Where events predate the name change, the original name "Burma" is used.
2. According to the *Asian Development Bank Outlook 1991*, in Myanmar's balance of payments, its current account deficit increased from US\$205 million in 1985 to US\$446 million in 1990.
