THE CONTRIBUTORS

Barbara Watson Andaya (Ph.D., Cornell University) is Professor of Asian Studies at the University of Hawai'i at Mānoa. Although her specific area of expertise is the western Malay-Indonesia archipelago, her teaching and research interests extend across all Southeast Asia. Her most recent book is *The Flaming Womb: Repositioning Women in Southeast Asian History, 1500–1800* (2006). Her current project is a history of the localization of Christianity in Southeast Asia, 1511–1900.

Leonard Y. Andaya received his B.A. in History from Yale University, and an M.A. and Ph.D. in Southeast Asian history at Cornell University. He has held positions at the University of Malaya, the Australian National University, the University of Auckland, and the University of Hawai'i, where he has been professor of Southeast Asian history since 1993. His area of specialization is early modern Southeast Asia, particularly Malaysia and Indonesia.

Robert Cribb is Professor in the College of Asia and the Pacific at the Australian National University. His research has focussed on Indonesian history, including the role of the criminal underworld in Indonesia's national struggle, the mass killing of communists in 1965–66, the nature of colonial law and the politics of nature conservation. He has also written a number of general works on Indonesian history including, most recently, a *Digital Atlas of Indonesian History* (2010).

R.E. Elson is Emeritus Professor of Southeast Asian History, the University of Queensland, Brisbane, Australia. His research focuses on the modern and

contemporary history of Southeast Asia, especially Indonesia. His current research projects include Islamism and secularism in modern Indonesian history and the history of maritime territoriality in the Indonesian seas. He is author of five books and numerous articles and chapters on the modern history of Indonesia and, more broadly, of Southeast Asia. He has served as President of the Asian Studies Association of Australia and as chair of the Australian Research Council's Expert Advisory Committee for the Humanities and Creative Arts. He was elected as a Fellow of the Australian Academy of the Humanities in 1995. His most recent book is *The Idea of Indonesia: A History* (2008).

Ishii Yoneo (1929–2010) was one of Japan's most respected scholars of Thailand and Southeast Asia. After a stint in the Foreign Ministry, Ishii-sensei returned to academe and was one of the founding members of the Center for Southeast Asian Studies at Kyoto University in 1965, later assuming the directorship (1985–90). He subsequently moved to Sophia University in 1990, where he taught and researched for seven years, including two years as director of the Institute of Asian Cultures. In 1997, he retired from Sophia and became the Rector of Kanda University of International Studies, a position he retained until 2004. He published profusely and also worked for the development of digital archives on Japan-Asia relations when serving as the director of the Japan Center for Asian Historical Records (JACAR), National Archives of Japan, from 2001 until he passed away.

Jeyamalar Kathirithamby-Wells formerly held the Chair of Asian History at the University of Malaya, Kuala Lumpur. Currently resident in the UK, she researches and teaches in Cambridge. She has worked extensively on Southeast Asia during the early modern period and, in recent years, has expanded her research interests to include environmental and conservation history. Apart from publishing numerous articles and monographs, she contributed to the *Cambridge History of Southeast Asia* (1992), edited with John Villers *The Southeast Asian Port and Polity* (1990) and more recently authored *Nature and Nation: Forests and Development in Peninsular Malaysia* (2005).

Koizumi Junko is Professor in the Center for Southeast Asian Studies, Kyoto University. She is a historian working on Thai history and historiography focused on the Early Bangkok period. Her recent English publications include "Between Tribute and Treaty: Sino-Siamese relations from the late nineteenth

century to the early twentieth century,” in Anthony Reid and Zheng Yangwen (ed.), *Negotiating Asymmetry: China's Place in Asia* (2009).

Ann Kumar is a Visiting Fellow, School of Culture, History & Language, College of Asia and the Pacific at the Australian National University where she long served as a lecturer. Her interests include the nation-state in contemporary Southeast Asia; Indonesian politics; Indonesian Islam; Indonesia's Writing Traditions; and early relations between Java and Japan. Her publications include *Illuminations: The Writing Traditions of Indonesia: Featuring Manuscripts from the National Library of Indonesia* (1996) and *Globalizing the Prehistory of Japan: Language, Genes and Civilization* (2009).

Li Tana is a Senior Fellow in Pacific and Asian History, School of Culture, History and Language, College of Asia and the Pacific, Australian National University. Her works include *Nguyen Cochinchina* (SEAP, Cornell, 1998) and *Water Frontier* (2004, co-ed. with Nola Cooke). She researches the maritime history of Vietnam and the history of overseas Chinese.

Denys Lombard (1938–1998) was educated at the Sorbonne, the École Pratique des Hautes Études and the École des Langues Orientales and was one of France's foremost Asianists. In 1993, he assumed the directorship of the École Française d'Extrême-Orient, a position he retained until his death. He was involved in researches on Southeast Asia, Overseas Chinese, the Arab world and the history of maritime Asia. Key works include *Le sultanat d'Atjeh* (1967); *Le carrefour javanais. Essai d'histoire globale* (1990), and with Claudine Salmon, *Les Chinois de Jakarta, temples et vie collective* (1980). He was instrumental in the establishment of the journal *Archipel*.

Pierre-Yves Manguin is a professor at the Ecole française d'Extrême-Orient (EFEO, French School of Asian Studies), and teaches at the Ecole des Hautes Etudes en Sciences Sociales (EHESS, Paris). His research focuses on history and archaeology of the coastal states and trade networks of Southeast Asia. He has led archaeological work in Indonesia and Vietnam and published on themes related to maritime history and archaeology of Southeast Asia, the Indian Ocean and South China Sea, and on the archaeology of Funan (Vietnam), Srivijaya (South Sumatra), and Tarumanagara (West Java).

Helen Reid graduated with a B.A. from Auckland in 1959, and a Ph.D. in French literature from the ANU in 1980. Initially she taught French

and English in France, Germany, Malaysia, Indonesia and Australia. More recently she was Policy Officer for Languages Other Than English in the ACT Teaching Service, then Language Specialist in the Australian Foreign Service, and most recently a Visiting Professor in the Language Resource Program at the University of California, Los Angeles.

Victor Lieberman, a specialist in precolonial Burma and a comparativist interested in global patterns, is the Marvin B. Becker Collegiate Professor of History and Professor of Southeast Asian History at the University of Michigan. His most recent work is a two-volume study *Strange Parallels: Southeast Asia in Global Context, c. 800–1830. Volume 1: Integration on the Mainland*, which won the 2004 World History Association Book Prize; and *Volume 2: Mainland Mirrors: Europe, Japan, China, South Asia, and the Islands*, which appeared in 2009.

Geoff Wade is a historian with interests in Sino-Southeast Asian historical interactions and comparative historiography. Currently a Senior Research Fellow in the Nalanda-Sriwijaya Centre, Institute of Southeast Asian Studies, Singapore, he was formerly engaged with the Southeast Asia-China Interactions cluster of the Asia Research Institute, National University of Singapore (2002–09) and, before that, with the China-ASEAN Project at the Centre of Asian Studies, University of Hong Kong (1996–2002). His online database *Southeast Asia in the Ming Shi-lu: An Open Access Resource* (<<http://epress.nus.edu.sg/msl/>>) provides in English translation 3,000+ references to Southeast Asia as extracted from the Ming imperial annals, while his most recent edited work *China and Southeast Asia* (2009) comprises a 6-volume survey of seminal works on Southeast Asia-China interactions over time.

Wang Gungwu obtained his B.A. (Hons.) and M.A. from the University of Malaya in Singapore and his Ph.D. from the University of London (1957). He is University Professor of the National University of Singapore, Emeritus Professor of the Australian National University, Fellow and former President of the Australian Academy of the Humanities; Foreign Honorary Member of the American Academy of Arts and Science; and Chairman of the East Asian Institute, the Institute of Southeast Asian Studies and the Lee Kuan Yew School of Public Policy in Singapore. From 1986 to 1995, he was Vice-Chancellor of the University of Hong Kong.

James Francis Warren is Professor of Southeast Asian Modern History at Murdoch University in Western Australia. He has held several visiting

professorships in Japan and Singapore and is the author of several influential books, including his ground breaking first volume, *The Sulu Zone 1768–1898, The Dynamics of External Trade, Slavery and Ethnicity in the Transformation of a Southeast Asian Maritime State*. He is currently working on a history of the impact of the typhoon on the Philippines. In 2003 he was awarded the Centenary Medal of Australia for service to Australian society and the Humanities in the study of Ethnohistory.
