ABOUT THE CONTRIBUTORS

Karin Dean is a senior researcher at the Estonian Institute of Humanities, Tallinn University. She is interested in various spatial practices and the dynamics of state and nation building at the margins of mainland Southeast Asia. As a consultant on Myanmar for the Henry Dunant Center for Humanitarian Dialogue (2002–06), she worked with the ethnic ceasefire and non-ceasefire groups at the Thai-Myanmar border. Her Ph.D. research at the National University of Singapore (1999–2002) and later research explore the Kachin spatial and social issues mostly at the Sino-Myanmar border.

Douglas Kammen obtained his Ph.D. at Cornell University and has taught at the University of Canterbury (Christchurch), Universitas Hasanuddin (Makassar), the National University of East Timor (Dili). He currently teaches in the Southeast Asia Programme at the National University of Singapore. He is the author of numerous journal articles and book chapters on social movements, military politics, and political violence in Indonesia and Timor-Leste.

Damien Kingsbury is Professor at Deakin University, Melbourne, and author and editor of a number of books on regional politics and security issues. In 2005, Prof. Kingsbury was political advisor to the Free Aceh Movement in the Helsinki peace talks which ended three decades of separatist conflict, and has since advised on models of autonomy and negotiation procedures to the West Papua National Coalition for Liberation, the Liberation Tigers of Tamil Eelam and the Moro Islamic Liberation Front.

Ronald J. May is an emeritus fellow of the Australian National University, attached to the State, Society and Governance in Melanesia programme, and

an adviser to the Papua New Guinea National Research Institute. He has been a frequent visitor to the Philippines since the 1970s and has written extensively on the Mindanao conflict. He is a former member of the Advisory Editorial Board of the *Journal of Muslim Minority Affairs*.

Duncan McCargo is Professor of Southeast Asian politics at the University of Leeds. His books on Thailand comprise: *Chamlong Srimuang and the New Thai Politics* (1997); *Politics and the Press in Thailand* (2000); *Reforming Thai Politics* (2002) (edited with U. Michelle Ann Miller is a Research Fellow at the Asia Research Institute, National University of Singapore. She previously taught at Deakin University and Charles Darwin University. Dr Miller is the author of *Rebellion and Reform in Indonesia: Jakarta's Security and Autonomy Policies in Aceh* (2009), as well as a number of refereed journal articles and book chapters on decentralization, minority rights, conflict resolution, the politics of Islamic law and governance issues, especially in Indonesia.

Thomas Parks is Regional Director for Conflict and Governance of the Asia Foundation and has been based in Bangkok since February 2008. Mr Parks has twelve years of experience in international development, primarily focused on South and Southeast Asia. Bilveer Singh is Associate Professor at the Department of Political Science, National University of Singapore, and is concurrently serving as Acting Head of the Center of Excellence for National Security, S. Rajaratnam School of International Studies, Nanyang Technological University. He returned to NUS in January 2012. He specializes in regional security issues with a particular focus on Indonesia. His recent books include: *Post-Cold War Australian-Indonesian Defense Relations* (2002); *The Talibanization of Southeast Asia: Losing the War on Terror to Islamist Extremists* (2007); and *Papua: Geopolitics and Papua's Quest for Nationhood* (2008).

Adérito de Jesus Soares has worked for various international, Indonesian and East Timorese NGOs, and was a law and political science lecturer in East Timor from 1999 to 2007.
