surah a chapter of the Qur'an

Syawwal the month after Ramadhan in which Muslims celebrate

Idul Fitri on the first day of month

syiqaq (or shikak) a conflict between a husband and wife which can be

solved by the family or the judge

tabligh akbar a religious gathering in an open area, such as a field,

with famous speakers (muballigh) giving orations

ta'lik talak postponing the fall of a talak on the occurrence of an

event; if the event occurred, the talak is legal

talak (or talaq) a divorce; ending a marriage with the husband saying

specific words to the wife, e.g., "I divorce you"

taqnin making a rule or law; legislation

ummah (or *umat*)

community, group of people; esp. Muslim community as identified by the integration of its ideology, religion, law, mission, and purpose of life and group consciousness, ethics and mores, irrespective of their differences in origin, race, language, colour of the skin, and so on.

undang-undang

law; rule established by the authority

wali

guardian; manager of a thing or affair of another

waqf

a charitable trust dedicated to some socially beneficial

purpose; religious endowment

wawasan Nusantara

an insight describing society, nation, mainland, ocean, and air as a union which cannot be separated; these elements are intertwined in political, socio-cultural,

economic, and secure-defensive union.

zakat

the obligation on every Muslim to give away a portion of his wealth to the poor and the needy each year; there are two kinds of *zakat*, i.e., *zakat fitrah* and *zakat maal*

zakat fitrah

a form of *zakat* that is imposed on each individual Muslim regardless of his wealth and is to be given out in the month of Ramadhan, before the Idul Fitri prayers

zakat maal

a form of *zakat* imposed on Muslims who have accumulated wealth; the rate is 2.5 per cent on all financial assets and stock-in-trade of businesseses, 10 per cent on agricultural produce of rain-irrigated cultivation, and 5 per cent on the produce of artificially

irrigated cultivation
