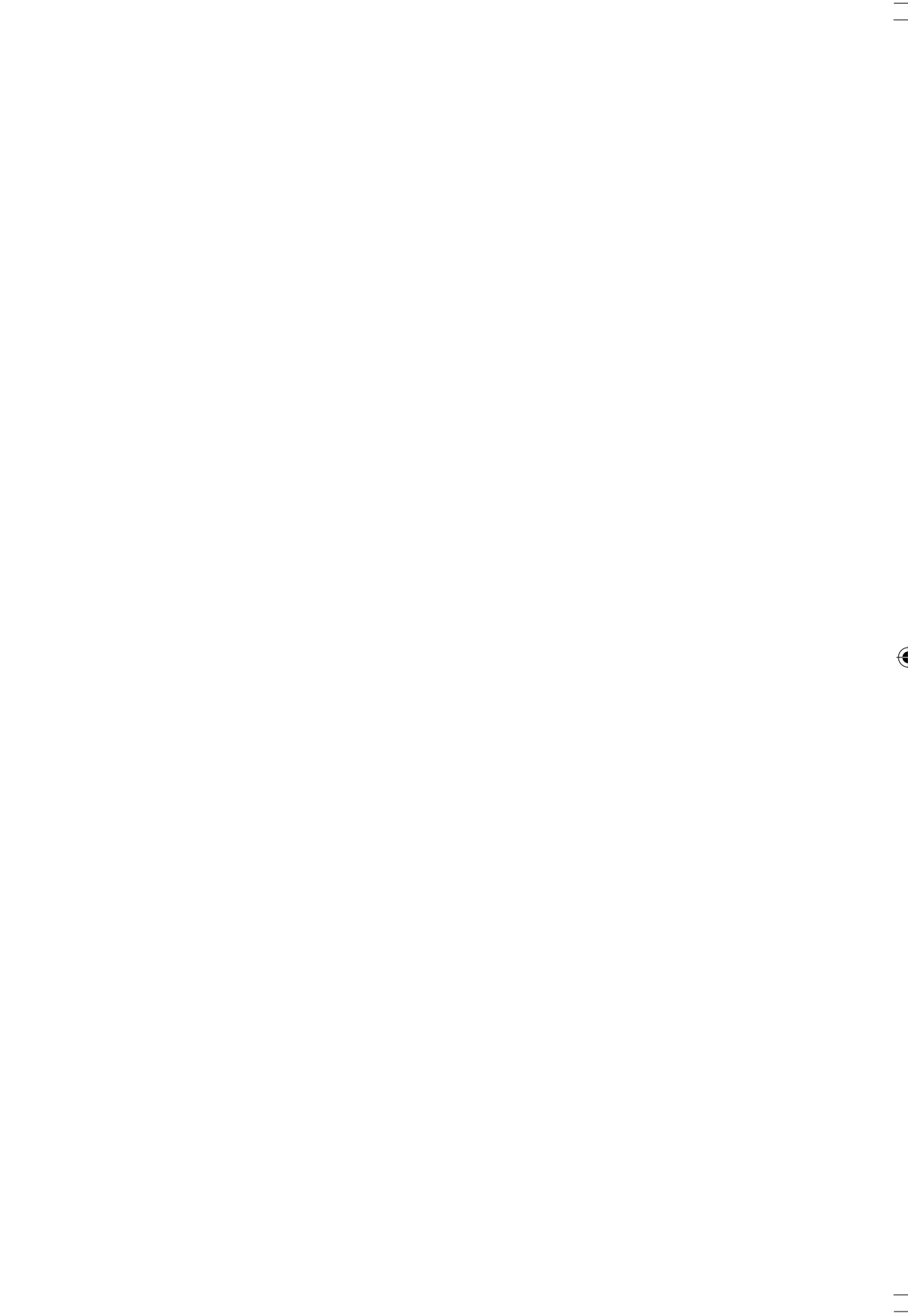

# Acknowledgements

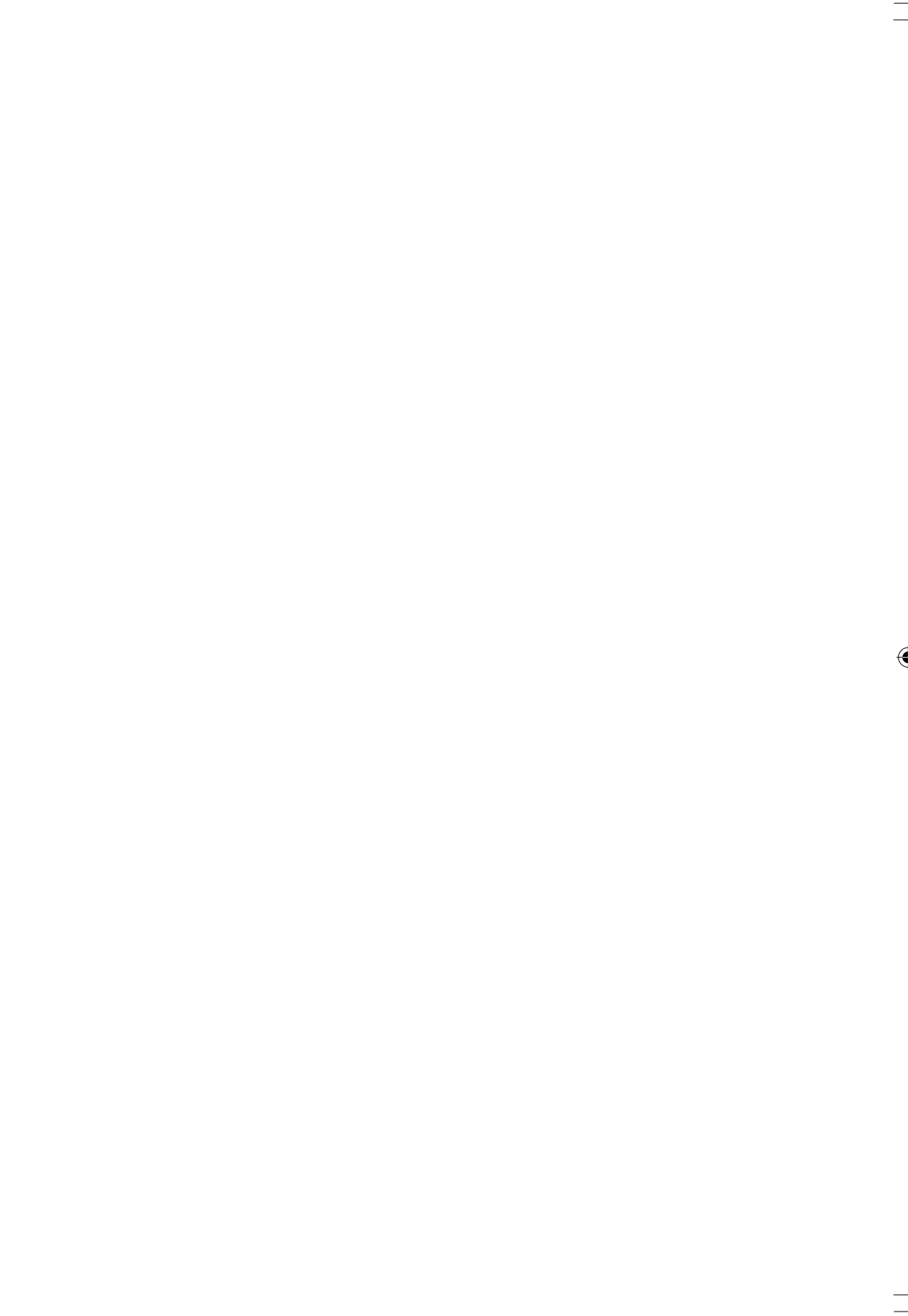
