Nick Bisley is the Executive Director of La Trobe Asia and Professor of International Relations at La Trobe University. He is currently the Editor-in-Chief of the *Australian Journal of International Affairs*, Australia's oldest scholarly journal in the field of International Relations. He is the author of many works on international relations, including *Issues*

His current research examines the causes and consequences of populism, xenophobia, and ethnocentrism. His first book, *Populism and Patronage: Why Populists Win Elections in India, Asia, and Beyond* is forthcoming.

Amy King is Senior Lecturer in the Strategic and Defence Studies Centre at the Australian National University (ANU)'s Coral Bell School of Asia Pacific Affairs. Michael Wesley is Professor of International Affairs and Dean of the College of Asia and the Pacific at the Australian National University (ANU). His 2011 book, *There Goes the Neighbourhood: Australia and the Rise of Asia*, was awarded the John Button Prize for the best writing on Australian politics and public policy. Previously Professor Wesley was the Director of the Coral Bell School of Asia Pacific Affairs at ANU from 2014 to 2016; the Executive Director of the Lowy Institute for International Policy from 2009 to 2012; Director of the Griffith Asia Institute at Griffith University from 2004 to 2009; and Assistant Director-General for Transnational Issues at the Office of National Assessments, Australia's peak intelligence agency, from 2003 to 2004. He gained his PhD from the University of St Andrews and his BA (Honours) from the University of Queensland.

Hugh White is Professor of Strategic Studies in the Strategic and Defence Studies Centre at the Australian National University (ANU)'s Coral Bell School of Asia Pacific Affairs. He studies Australian strategic and defence policy, and the regional and global security issues affecting Australia. He has been an intelligence analyst, a journalist, a senior staffer to Kim Beazley and Bob Hawke, a senior official in the Defence Department, and the first Director of Australian Strategic Policy Institute (ASPI). He was the principal author of Australia's 2000 Defence White Paper. His recent publications include the Quarterly Essay, *Power Shift: Australia's Future Between Washington and Beijing* and *The China Choice: Why America Should Share Power*.
