Her latest work are the book chapters, “Punitive Populism and Disinformation as Legacies of Duterte” and “Critical Incidents and Auto Analysis: Photojournalists’ Introspection while Covering the Drug War in the Philippines”, published in 2023 and 2021 respectively.
