# About the Contributors

**Myrna S. Austria** is a University Fellow and Full Professor at the School of Economics, De La Salle University (DLSU). She has published journal articles, monographs, book chapters and policy briefs on trade, investment and industrial policy, development economics, competition policy, and regional economic integration. She earned her master's degree and PhD in economics from the Australian National University. She has served DLSU in various capacities: Vice-Chancellor for Academics (May 2010–July 2015); Dean of the College of Business & Economics (May 2006–May 2010); and Director of the Center for Business and Economics Research and Development (January 2003–May 2006). She has served several top universities in ASEAN as Chief and Lead Quality Assurance Assessor under the ASEAN University Network (AUN).

**Cristina Regina Bonoan** is a lawyer and Senior Lecturer at the University of the Philippines (UP) College of Law. Her research interests revolve around rights, access to justice and the rule of law. She received her master's degree in international affairs, specializing in human rights and development, from the Columbia University School of International and Public Affairs. In addition, she holds a Bachelor of Laws from the UP College of Law and a Bachelor of Science in Legal Management from the Ateneo de Manila University. She has worked as a consultant for the Commission on Human Rights, the Asian Development Bank, and other international and non-governmental organizations, specializing in governance, the rule of law reform and human rights.

**Nicole Curato** is Professor of Political Sociology at the Centre for Deliberative Democracy and Global Governance at the University

of Canberra. She is the author of *Democracy in a Time of Misery: From Spectacular Tragedy to Deliberative Action* (2019) and *A Duterte Reader: Critical Essays on Rodrigo Duterte's Early Presidency* (2017).

**Imelda Deinla** is currently Senior Lecturer at the School of Law, University of New England and Visiting Senior Fellow at the School of Government, Ateneo de Manila University. She was previously Associate Professor at the School of Government at Ateneo de Manila University and Convenor of BOSES Pilipinas, the first university-based public opinion survey outfit in the Philippines. Her research interests include rule of law, justice and democracy in ASEAN, Southeast Asia and the Philippines. Her current research is on electoral violence, misinformation, and crime and punitiveness. She is the author of *The Development of the Rule of Law in ASEAN: The State and Regional Integration* (2017), co-editor of *From Aquino to Duterte: Change, Continuity and Rupture* (2017), and co-editor of *Philippine Conglomerates and Inclusive Development: Tracking a Unique Trajectory in Asia* (forthcoming, March 2024).

**Benjamin E. Diokno** is an economist and has served as the Secretary of Finance under the administration of President Ferdinand 'Bong Bong' Marcos Jr. since June 2022. He previously served as Secretary of Budget and Management under the administration of President Rodrigo Duterte (2016–19) and under President Joseph Estrada (1998–2001). He has also served as the Governor of the Central Bank of the Philippines (Bangko Sentral ng Philipinas) and ex officio chairman of the Anti-Money Laundering Council (2019–22) under President Duterte. He holds a bachelor's degree in public administration from the University of the Philippines (UP) Diliman, master's degrees in public administration and in economics from UP Diliman, a MA in political economy from the Johns Hopkins University, USA and a PhD in economics from Syracuse University, USA.

**Björn Dressel** is an Associate Professor and inaugural Director of the Philippines Institute at the Australian National University (ANU). His research is concerned with comparative constitutionalism, judicial politics and governance, and public sector reform in Asia. He has published in a range of international journals, including *Governance, Administration &*



*Society, International Political Science Review* and *Pacific Review*. He is the editor of *The Judicialization of Politics in Asia* (2012) and co-editor of *Politics and Constitutions in Southeast Asia* (2016) and *From Aquino II to Duterte: Continuity, Change—and Rupture* (2019).

**Georgi Engelbrecht** is a Senior Analyst with the International Crisis Group. He is based in Manila. Before joining the International Crisis Group in late 2019, Georgi worked in Mindanao as part of a multinational peacekeeping mission monitoring the ceasefire between the Philippine government and the Moro Islamic Liberation Front.

**Bianca Ysabelle Franco** graduated with a master's degree in sociology from the University of the Philippines Diliman. She was formerly a research associate at the Development Studies Program of the Ateneo de Manila University where she worked on projects about human rights, deliberative democracy and conflict studies. Her written work has been published on the academic blogs *New Mandala* (Australian National University) and *Broad Agenda* (University of Canberra) and on the news websites *Globe Post* (United States) and *Rappler* (Philippines).

**Rosalie Arcala Hall** is Professor of Political Science and Scientist III at the University of the Philippines Visayas (UPV) in Miagao, Iloilo. She earned her Masters and PhD from Northeastern University, Boston, USA. She has completed research projects and published extensively on civil-military relations, security in the Bangsamoro area and rebel integration with grants from Toyota Foundation, the Nippon Foundation, The Asia Foundation and the Australian National University. She is a member of the Philippine Commission on Higher Education Technical Panel for Political Science and past president of the Philippine Political Science Association (2019–21).

**Gail Tan Ilagan** retired in 2023 from the chair of the Department of Psychology at Ateneo de Davao University. She was the Director of the Davao-based Center of Psychological Extension and Research Services (COPERS) from 2011 to 2018. She headed the Psychological Association of the Philippines' Task Force for Emergency MHPSS Response to the Marawi Crisis from June 2017 to March 2018.

**Clarke Jones** is a criminologist and senior research fellow based at the School of Medicine and Psychology at the Australian National University (ANU). His expertise includes interventions/ rehabilitation, radicalization/ prison radicalization, correctional reform and prison gangs. Dr Jones has applied his research to prison and jail reform in the Philippines correctional system over the past 15 years and continues to advise Philippines correctional agencies—the Bureau of Corrections (BuCor), the Bureau and Jail Management and Penology (BJMP)—on areas such as the management of high-risk offenders and prison gangs. He has also worked as a senior consultant for the United Nations Development Program (UNDP) and the United Nations Office of Drugs and Crime (UNODC). Before moving into academia in 2010, he worked for over 16 years in several areas of Australian national security, including police, military and intelligence. In 2002, he was awarded the Chief of the Australian Defence Force Fellow and, based on this fellowship, completed a PhD at the University of New South Wales in 2010.

**Ronald U. Mendoza** is Regional Director for Southeast Asia at IDinsight, a policy research organization focused on international development policy and programmes, with a menu of data-driven technical assistance and capacity-building services. Dr Mendoza is a governance and institutional reforms specialist with over 25 years of experience in development policy and public administration reforms. Prior to joining IDinsight, he served as Dean and Professor at the Ateneo de Manila University School of Government. Between August 2020 and July 2022, he also served as Chief of Party of PARTICIPATE, a three-year USAID project that focused on supporting citizens' participation in governance and strengthening democratic and governance institutions. From 2011 to 2015, he was an Associate Professor of Economics at the Asian Institute of Management (AIM) and the Executive Director of the AIM Rizalino S. Navarro Policy Center for Competitiveness. His research background includes work with UNICEF, UNDP, the Federal Reserve Bank of Boston, the Economist Intelligence Unit (EIU), and several Manila-based non-governmental organizations. In early 2021, the United Nations Economic and Social Council (UN ECOSOC) approved Dr Mendoza's appointment to serve with the 24-person UN Committee of the Experts on Public Administration (CEPA 2021–2025). And in early 2023, he was listed

among the Philippines' top 100 scientists in the AD Scientific Index 2023 based on the total number of citations in the last five years.

**Raymund E. Narag** is an Associate Professor at the School of Justice and Public Safety in Southern Illinois University Carbondale. His research interests include court and correctional management, comparative criminal justice systems and qualitative research. He implemented the Community Bail Bond programme in the Philippines where Persons Deprived of Liberty (PDLs) and Persons with Drug Use Disorders (PWDUDs) are released under the supervision of community volunteers. He also serves as a consultant with the United Nations Office of Drugs and Crime (UNODC) on correctional concerns in the Philippines.

**Antoinette R. Raquiza** is Professor at the Asian Center, University of the Philippines Diliman, where she teaches Southeast Asian Studies and Philippine Development Studies. She received her PhD in political science from the City University of New York Graduate Center and has written on comparative political economy and political institutions, including *State Structure, Policy Formation, and Economic Development in Southeast Asia: The Political Economy of Thailand and the Philippines*, as well as on Philippine politics, governance and development. She is the convenor of the Political Economy Program of the UP Center for Integrative and Development Studies, vice president of the Manila-based think tank, Asia-Pacific Pathways for Progress Foundation, Inc. (APFFI), and chair of the Consortium for Southeast Asian Studies in Asia (SEASIA), a network of 15 leading area studies institutions in the region.

**Maria Lulu Reyes** is Professor of Law at the Saint Louis University in Baguio City, Philippines, where she also heads its Master of Laws programme. She is active in non-government and civil society work in the Cordillera region of the Philippines, and her research interests include justice and indigenous people, law and violence against women.

**Mina Roces** is a Professor of History at the School of Humanities and Languages, University of New South Wales, Sydney, Australia. A PhD graduate from the University of Michigan, she is the author of five monographs: *Women, Power and Kinship Politics: Female Power in Post-war*

*Philippines* (1998), *Kinship Politics in Post-war Philippines: The Lopez Family, 1946–2000* (2001), *Women’s Movements and the Filipina, 1986–2008* (2012), *The Filipino Migration Experience: Global Agents of Change* (2021, which won the 2022 NSW Premier’s General History Prize), and *Gender in Southeast Asia* (2022). She is the recipient of the 2019 Grant Goodman Prize for Excellence in Philippine Historical Studies given by the Philippine Studies Group, Association for Asian Studies, USA. In 2016 she was elected to the Australian Academy of the Humanities.

**Steven Rood** is Fellow-in-Residence at the Social Weather Stations and Visiting Fellow at the Australian National University. He was Professor of Political Science at the University of the Philippines Baguio from 1981 to 1999 and Philippine Country Representative for the Asia Foundation from 1999 to 2017. From 2009 to 2013, he was a member of the International Contact Group for the negotiations between the Philippine government and the Moro Islamic Liberation Front, and from 2013 to 2017 he was on the International Monitoring Team examining the progress of the agreements reached in those talks. He is the author of *The Philippines: What Everyone Needs to Know* (2019).

**Manual Solis** is currently a Senior Lecturer of Law at Deakin University and Law Course Coordinator at the National Indigenous Knowledges Education Research Innovation (NIKERI) Institute in Australia. He has been a Senior Research Fellow at the Manila Observatory since 2019. Dr Solis is also an Adjunct Professor on Climate Change Law and Energy Transition at the San Beda University Graduate School of Law and the University of Santo Tomas Graduate School of Law in the Philippines. He was a Japan Foundation Visiting Scholar at Waseda University, Tokyo, Japan in 2022.

**Veronica L. Taylor** is a socio-legal scholar and Professor of Law and Regulation in the School of Regulation and Global Governance (RegNet) at the Australian National University. She is a former Dean of the ANU College of Asia and the Pacific, an ANU Public Policy Fellow and the designer of the University’s education programs in Regulation and Governance. Her work focuses on the professional practice of regulation, regulatory justice, rule of law, institutional reform and corporate

governance. She specializes in the design and evaluation of legal reform projects in authoritarian and volatile settings and for transition economies, including Afghanistan, China, Indonesia, Mindanao, Myanmar and Vietnam. In Australia, Professor Taylor is the Senior Academic Advisor to the National Regulator Community of Practice and an Expert Advisor to the Regulatory Reform Division of the Department of Finance. She is a non-Executive Director of ANU Enterprise and of the Social Research Centre. She received the Japanese Foreign Minister's Citation in 2017.
