SYED HUSSEIN ALATAS is the Vice-Chancellor of the University of Malaya. Prior to taking up that appointment he was Professor of Malay Studies at the National University of Singapore. His undergraduate and postgraduate studies were conducted at the University of Amsterdam, Holland, where he received his Doctorate from the Political and Social Sciences Faculty in 1963. His areas of interest are the sociology of modernization, intellectuals, corruption, and Islam in Southeast Asia. His major publications on the region are *The Myth of the Lazy Native* (London: Frank Cass, 1977), *Intellectuals in Developing Societies* (London: Frank Cass, 1977), and *The Problem of Corruption* (Singapore: Times Books International, 1986).

W. TIMOTHY AUSTIN is an Associate Professor of Criminology at Indiana University of Pennsylvania. After receiving his Ph.D. in Sociology from the University of Georgia in 1972, he taught criminology and the sociology of deviant behaviour at North Carolina State University and Montana State University. His research specialty focuses upon informal mechanisms of dispute processing, with particular attention to Singapore and the Philippines.

G.W. BARTHOLOMEW was Professor of Law at the then University of Singapore from 1966 to 1976 and Foundation Dean of the Faculty of Law at the New South Wales Institute of Technology from 1976 to 1987. Currently he is Head of School in the Faculty of Law at the University of Technology in Sydney, Australia. Among his publications are "Commercial Law of Malaysia", *Malayan Law Journal* 30 (1964) and (with E. Srinivasagam and P. Netto) *Sesquicentennial Chronological Tables of the Written Laws of the Republic of Singapore 1834-1984* (Singapore: Malayan Law Journal, 1987).

RALPH C. BRYANT is a Senior Fellow in the Economic Studies Program at the Brookings Institution. His primary field of interest is international economics, in particular the monetary and financial aspects; secondary fields include monetary theory and policy, applied macro-economics, and the theory of economic policy.

He was awarded a BA degree *magna cum laude* in History, the Arts, and Letters from Yale University in 1960. As a Rhodes Scholar, he received a B. Phil. degree in Economics from Oxford University in 1963. In 1966 he received a Ph.D. degree in Economics from

the Graduate School of Yale University. He joined the Division of International Finance of the Federal Reserve Board in 1965. In 1969 he was awarded an International Affairs Fellowship by the Council on Foreign Relations and spent a year at University College London and the Bank of England. He returned to the Federal Reserve Board in 1970, and in 1972 was appointed Director of the Division of International Finance and Associate Economist for the Federal Open Market Committee. He became a Senior Fellow at the Brookings Institution in 1976. Since 1982 he has been a Professorial Lecturer in International Finance at the School of Advanced International Studies of Johns Hopkins University. In 1983 he was the first recipient of the Distinguished Fellowship in International Banking and Finance at the Institute of Southeast Asian Studies in Singapore. He has frequently served as a consultant to, or participated in, advisory and review groups for, among others, the Federal Reserve Board, the World Bank, the International Monetary Fund, the U.S. Treasury, and the National Science Foundation.

Professor Bryant's publications include *Money and Monetary Policy in Interdependent Nations* (Washington, D.C.: Brookings Institution, 1980); *Financial Interdependence and Variability of Exchange Rates* (Washington, D.C.: Brookings Institution, 1980); *Controlling Money: The Federal Reserve and Its Critics* (Washington, D.C.: Brookings Institution, 1983); and *International Financial Intermediation* (Washington, D.C.: Brookings Institution, 1987).

CHAN HENG CHEE is an Associate Professor and between 1985 and 1987 was Head of the Department of Political Science at the National University of Singapore. She has published several books and numerous articles on Singapore politics and regional politics in Southeast Asia, including *The Dynamics of One Party Dominance: The PAP at the Grass-Roots* (Singapore: Singapore University Press, 1976); *The Politics of Survival, 1965-1967* (Kuala Lumpur: Oxford University Press, 1971); *A Sensation of Independence. A Political Biography of David Marshall* (Singapore: Oxford University Press, 1984); and (with Jon S.T. Quah and Seah Chee Meow, eds.) *Government and Politics of Singapore* (Singapore: Oxford University Press, 1985). Professor Chan was on secondment as the first Director of the newly established Institute of Policy Studies in Singapore before taking up her current position as Singapore's Permanent Representative to the United Nations in New York.

CHENG SOO MAY obtained her Ph.D. from Queensland University in 1987. She was a researcher and a personnel officer in the private sector before she joined the Department of Organizational Behaviour at the National University of Singapore in 1983, where she teaches Human Resource Management and Organizational Behaviour.

CHIA LIN SIEN, M.Sc. (McGill), Ph.D. (Singapore), MCIT (London) is Associate Professor in the Department of Geography at the National University of Singapore. He is a member of the Singapore Public Transport Council and is the Co-ordinator of the Regional Shipping Unit in the Institute of Southeast Asian Studies. His fields of research are maritime geography and transportation with special reference to Southeast Asia. He has numerous publications, including jointly edited books on *Southeast Asian Seas: Frontiers for Development* (New York: McGraw-Hill Book Co., 1981) and

Handmaiden of Trade: A Study on ASEAN-Australian Shipping (Singapore: Singapore University Press, 1989).

CHIA SIOW YUE is an Associate Professor of Economics at the National University of Singapore. She is a specialist in international economics and development economics, and has written extensively in the areas of industrialization, foreign investment, trade, and women's economic participation. She has special interests in Singapore, ASEAN, and the Asian newly industrializing countries.

CHUA BENG HUAT is currently a Senior Lecturer in the Department of Sociology at the National University of Singapore. He received his Ph.D. from York University in Ontario, Canada. Prior to returning to Singapore, he was an Associate Professor at Trent University, Peterborough, Canada. Subsequently he was Senior Principal Research Officer and Head of the Social Research Section at the Housing and Development Board, Singapore. Among his publications on Singapore society are *Designed for Living: Public Housing Architecture in Singapore* (Singapore: Housing and Development Board, 1985); and essays on housing and ideological developments.

FEREIDUN FESHARAKI is the Leader of the Energy Program at the Resource Systems Institute, the East-West Center, Honolulu, Hawaii. He was born in Iran and received his Ph.D. in Economics from Surrey University. Prior to joining the East-West Center in 1979, he was a Visiting Fellow at the Center for Middle Eastern Studies of Harvard University, a Senior Fellow at the Institute for International Economic and Political Studies in Iran, and the Energy Adviser to the Prime Minister of Iran (1977/78), in which capacity he attended OPEC Ministerial Conferences. His area of specialization is oil and gas market analysis and the downstream petroleum sector, with special emphasis on the Middle East, the Asia-Pacific region, the Caribbean, and the United States. Dr Fesharaki is the author and/or editor of several books and monographs and more than fifty papers on the international oil and gas industry. He is Vice-President for International Relations of the International Association of Energy Economists and a member of the Editorial Board of *Energy Policy*.

RONALD FINDLAY is the Ragnar Nurske Professor of Economics at Columbia University in the City of New York. He has taught in the University of Rangoon and has held visiting professorships in Stockholm and Geneva. In addition to numerous articles in scholarly journals, he has published *Trade and Specialization* (Harmondsworth, Middlesex: Penguin Books, 1970) and *International Trade and Development Theory* (New York: Columbia University Press, 1973).

ARTHUR LEE GILBERT received his undergraduate education at the University of Denver and his MA in International Development from the University of Oregon in 1980, with a thesis on "Health Policy for Saudi Arabia's Third Plan". Since then he has directed the delivery of information services to local government agencies in California and Oregon, served as a consultant to corporations and governments in Europe, the Middle East and Asia, and taught management and systems at the postgraduate level. During 1982-86 he led the executive-education programme at the Institute of Systems

Science of the National University of Singapore. He is now the first Fellow in the Future Information Systems Faculty Program at the postgraduate School of Business Administration of Harvard University, where he specializes in the study of the transfer of information technology within the Pacific Rim.

HERBERT G. GRUBEL was born and raised in Germany but received his professional education at Rutgers University and Yale University (Ph.D. in Economics, 1962) in the United States. He has held academic positions at Stanford University, the University of Chicago, the University of Pennsylvania, Oxford University, the Australian National University, the University of Nairobi, the University of Cape Town, the United States Treasury, the Institute for World Economics in Kiel, and the Institute of Southeast Asian Studies in Singapore. He has been Professor of Economics at Simon Fraser University since 1972. He is an editorial adviser to a number of economics journals and research institutes, including the Fraser Institute in Vancouver. He has published a dozen scholarly treatises, textbooks, and policy-oriented monographs, as well as a large number of articles in professional journals and compendia. Most of his scholarly contributions and teaching responsibilities are in the field of international trade and finance.

HO WING MENG is an Associate Professor in the Department of Philosophy at the National University of Singapore. He obtained his BA (Hons.) from the University of Malaya in Singapore in 1958, his MA from the University of Singapore in 1960, and his D. Phil. from the University of Oxford in 1965, where he wrote his doctoral thesis on the Philosophy of Science with special reference to the Theory of Evolution. After his return to the University of Singapore, he lectured on the Philosophy of Science for several years. During the past ten years or so his interest has shifted to Aesthetics and the History of Art. Professor Ho is an avid student of Chinese ceramics, but his main publications in the History of Art are a trilogy on the cultural heritage of the Straits Chinese. His other publications include twenty-eight articles on various topics of a philosophical and semi-philosophical nature, including the Philosophy of Education, Logic, Political Theory, and Values.

MEHEROO JUSSAWALLA, Ph.D., is a Research Associate/Economist at the East-West Center, Honolulu, Hawaii, which she joined in 1978. Her main area of research is telecommunications and information economics. She is also an Affiliate Professor of Economics and of Communications at the University of Hawaii. She is the author of *Communication Economics and Development* (New York: Pergamon Press, 1982); *Communication and Information Economics: New Perspectives* (Amsterdam: North Holland, 1984); (with Dan J. Wedemeyer and Vijay Menon, eds.) *The Passing of Remoteness* (Singapore: Institute of Southeast Asian Studies, 1986); *The Calculus of International Communications* (Littleton, Colorado: Libraries Unlimited, 1987); and *Telecommunications, Economics and International Regulatory Policy* (New York: Greenwood Press, 1986). Her articles have appeared in *Telecommunications Policy*, *Intermedia*, *Information Economics and Policy*, and *Transborder Data Report*. Currently she is conducting research on the economics of choice of available satellite options in the Pacific.

KOH AI TEE is a Lecturer in the Department of Economics and Statistics at the National University of Singapore. Her research interests are in the areas of international trade and finance. She has also worked on the theoretical modelling of business cycles and exchange controls, as well as undertaking empirical work on services and industrial and trade-co-operation issues in the ASEAN region. She is co-author (with Lawrence B. Krause and Lee [Tsao] Yuan) of *The Singapore Economy Reconsidered* (Singapore: Institute of Southeast Asian Studies, 1987).

KOH TAI ANN was educated at the University of Singapore, where she received her Ph.D. in 1971. She was a Nuffield Commonwealth Fellow in the Department of English at Manchester University, 1973-74, a Fellow at the Institute of Southeast Asian Studies in Singapore, 1983, a Fulbright Fellow in the Department of English at Cornell University, 1987, and is at present Senior Lecturer in the Department of English Language and Literature at the National University of Singapore. Her publications include "The Singapore Experience: Cultural Development in the Global Village" in *Southeast Asian Affairs 1980* (Singapore: Institute of Southeast Asian Studies, 1980), and articles dealing with questions of cultural tradition and identity with regard to post-colonial societies and their literatures in English. She is currently Editor of *Commentary*, the journal of the National University of Singapore Society, and a member of the Resource Panel of the Government Parliamentary Committee on Education in Singapore.

LAWRENCE B. KRAUSE is a Professor in the Graduate School of International Relations and Pacific Studies at the University of California in San Diego. He has studied many of the economies of the Pacific Basin when at the Brookings Institution. In 1986 he was a Distinguished Fellow in International Banking and Finance at the Institute of Southeast Asian Studies in Singapore.

LEE BOON HIOK is a Senior Lecturer in the Department of Political Science at the National University of Singapore. He was Sub-Dean of the Faculty of Arts and Social Sciences in the University of Singapore from 1977 to 1980. He received his BA (Hons.) and MA from the University of California, Los Angeles, and his Ph.D. from the University of Hawaii. He was a consultant to the United Nations Asian and Pacific Development Administration Centre from 1978 to 1980. He has written a number of articles on public administration, politics, and trade unionism, and is the author of *Planning and Management of the University of Singapore and Nanyang University Prior to Merger* (Singapore: Regional Institute of Higher Education and Development, 1983).

EDWIN LEE is a Senior Lecturer in History at the National University of Singapore. He obtained his MA degree from Cornell University in 1971. The dissertation he began there was the germ of a book, *The Towns of Sabah* (Singapore: Singapore University Press, 1976; reprinted 1977). Since that time he has switched to the field of Singapore history, and received a Ph.D. from the National University of Singapore in 1982.

LEE SOO ANN is a Professor in the Department of Business Policy at the National University of Singapore. Prior to his appointment in 1983, he had been Professor of Economics and Statistics at the same University, where he had begun his academic career in 1961 as Assistant Lecturer. He is the author of *Economic Growth and the Public Sector in Malaya and Singapore* (London: Oxford University Press, 1974); *Industrialisation in Singapore* (Melbourne: Longmans of Australia, 1974); *Singapore Goes Transnational* (Singapore: Eastern Universities Press, 1977); and *Economic Planning and Project Evaluation* (Singapore: Singapore University Press, 1977).

MICHAEL LEIFER is Professor of International Relations at the London School of Economics and Political Science where he has taught since 1969. He has held visiting appointments at the Australian National University, the University of the Philippines, and Cornell University, and was Visiting Professor of Political Science at the National University of Singapore in 1986–87. His more recent publications include *Indonesia's Foreign Policy* (London: Allen and Unwin for the Royal Institute of International Affairs, 1983) and *The Balance of Power in East Asia* (London: MacMillan, 1986). He is currently completing a study of the security role of ASEAN.

LIM CHONG YAH is currently Professor of Economics and Head of the Department of Economics and Statistics at the National University of Singapore. He obtained his D. Phil. in Economics from the University of Oxford in 1964. He is also currently the Chairman of the National Wages Council, President of the Economic Society of Singapore, and Editor of the *Singapore Economic Review*. He is the author of numerous articles and books, including the recently published *Policy Options for the Singapore Economy* (Singapore: McGraw-Hill Book Co., 1988). He was awarded the Public Service Star by the Singapore Government in 1976 and the Meritorious Service Medal in 1983. In 1985, the National Trades Union Congress in Singapore conferred on him the Meritorious Service Award.

LINDA Y.C. LIM, BA (Cantab.), MA (Yale), Ph.D. (Michigan); is a Singaporean who teaches international business, development economics, and Southeast Asian Studies at the University of Michigan in Ann Arbor, where she is concurrently Research Director of the Southeast Asia Business Education and Resources Program and Editor of the quarterly publication *Southeast Asia Business*. She is the author or co-author of three books and more than fifty monographs and articles on the Singapore economy, on export-oriented industrialization, multinationals, labour, women, and Overseas Chinese business in Southeast Asia, and on Asia-Pacific trade issues. She is a frequent consultant to United Nations and other international development agencies, and is a member of the Southeast Asia Council of the Association for Asian Studies (USA), and the Contemporary Affairs Committee of the Asia Society (New York).

SHIRLEY LIM, born in Melaka, received a BA with First-Class Honours from the University of Malaya in 1967 and a Ph.D. from Brandeis University in 1973. Her first book of poems, *Crossing the Peninsula*, won the Commonwealth Poetry Prize in 1980. She was a Research Fellow at the Institute of Southeast Asian Studies in Singapore in 1985–86, and is currently an Associate Professor in the State University of New York.

TREVOR LING was born in London and educated at Oxford University and the School of Oriental and African Studies of London University. After two years in Rangoon, he taught at Leeds University and Manchester University from 1963 to 1983, specializing in the comparative study of religion, and from 1984 to 1987 was Visiting Professor in the Sociology Department of the National University of Singapore. He is currently a Visiting Fellow at the Institute of Southeast Asian Studies in Singapore.

JUZAR MOTTWALLA is currently Director of the Institute of Systems Science at the National University of Singapore. He received his Ph.D. from the University of Wisconsin. He has been a consultant to several multinational, regional, and local companies. He is the author of several papers on decision-support systems and organizational decision-making. He is a Member of the National Computer Board and Vice-President of the Singapore Computer Society. He is also Chairman of the National Committee on Information Technology Research and Development.

ONG JIN HUI was educated at the University of Singapore and Indiana University. He is now Associate Professor in the Department of Sociology and Director of the Centre for Advanced Studies at the National University of Singapore. In the area of his special interest in crime and social control he has acted as consultant to the Singapore Police Force and the Ministry of Home Affairs. His other interests are primarily in the various aspects of Applied Sociology within the Singapore context.

OOI GIOK LING obtained her Ph.D. from the Department of Human Geography in the Research School of Pacific Studies at the Australian National University, Canberra. She has been a lecturer at the University of Malaya and is now working as a Research Fellow at the Institute of Policy Studies in Singapore. Her research interests focus on urban issues such as health care, utilities supply, industrial estates and, more recently, on Town Councils.

PANG ENG FONG, a Singaporean, has worked at the National University of Singapore since 1967. His master's degree and doctoral work were on housing policy at respectively the University of Wales and the University of Adelaide. He has held senior academic posts at the South Australian Institute of Technology and the National University of Singapore.

NIRMALA PURU SHOTAM is a Lecturer in the Department of Sociology, National University of Singapore. She holds a Masters degree from the Tata Institute of Social Sciences, Bombay, India and a Ph.D. from the National University of Singapore. Her publications include (with Sharon Siddique) *Singapore's Little India* (Singapore: Institute of Southeast Asian Studies, 1982), which won the National Book Development Council of Singapore Best Book Award for 1984.

JON S.T. QUAH is an Associate Professor of Political Science at the National University of Singapore. He was educated at the University of Singapore and the Florida State University, where he received his Ph.D. in 1975. He was Professional Associate at the Culture Learning Institute, East-West Center (1978); Visiting Scholar at the Harvard Yenching Institute (1979-80); and Research Associate at the Institute of Governmental Studies, University of California, Berkeley (September 1986-May 1987). He has published over fifty articles on public administration in the ASEAN countries, the police in Singapore, and Singapore politics, and two books on family-planning management. He is co-editor (with Chan Heng Chee and Seah Chee Meow) of *Government and Politics of Singapore* (Singapore: Oxford University Press, rev. ed. 1987); and co-author (with Stella R. Quah) of *Friends in Blue: The Police and the Public in Singapore* (Singapore: Oxford University Press, 1987). Currently Professor Quah is on secondment as Acting Director of the Institute of Policy Studies in Singapore.

STELLA R. QUAH is a Senior Lecturer in Sociology at the National University of Singapore. She obtained her M.Sc. degree from the Florida State University in 1971 and her Ph.D. from the University of Singapore in 1980. She was Resource Person for the Sixteenth Summer Seminar in Population at the Population Institute, East-West Center (1985); Consultant to the World Health Organization (1980, 1982, 1983); Research Associate at the Institute of Governmental Studies, University of California, Berkeley (September 1986-May 1987); and Visiting Scholar at the Massachusetts Institute of Technology, Cambridge, Mass., 1987). She has conducted research and published articles on social policy, sociology of health, sociology of the family, and crime and delinquency. Among her most recent publications are *Balancing Autonomy and Control: The Case of Professionals in Singapore* (Cambridge, Mass.: Center for International Studies, Massachusetts Institute of Technology, 1984); and (with Jon S.T. Quah) *Friends in Blue: The Police and the Public in Singapore* (Singapore: Oxford University Press, 1987).

HANS CHRISTOPH RIEGER was born and educated in England and studied engineering and economics in West Germany. Since 1963 he has been a Research Fellow at the South Asia Institute of Heidelberg University and has spent several years each in India and Nepal. From 1980 to 1987 he was the Representative of the Konrad Adenauer Foundation and a Visiting Fellow at the Institute of Southeast Asian Studies in Singapore, attached to its ASEAN Economic Research Unit.

SEAH CHEE MEOW, Ph.D., received his degrees from the University of Singapore and the University of Manchester. Subsequent to 1971 he was on the staff of the Political Science Department at the University of Singapore (renamed the National University of Singapore in 1980) until his transfer to the Department of Japanese Studies in 1986. He is now an Associate Professor and Head of that Department.

SHARON SIDDIQUE, who holds a Ph.D. from the University of Bielefeld in West Germany, is a Senior Fellow at the Institute of Southeast Asian Studies in Singapore. TAN CHWEE HUAT, B.Acc. (Hons.), MBA, MS (Industrial Relations), Ph.D. (International Business), is an Associate Professor and Head of the Department of Organizational Behaviour at the National University of Singapore. He is also Dean of the Faculty of Business Administration. He has published books and articles on management, industrial relations, public enterprise, and financial markets.

KEVIN TAN YEW LEE, LL.B. (Hons.) (Singapore) is Lecturer in the Faculty of Law at the National University of Singapore.

TAY KHENG SOON is an architect in Singapore with a practice called Akitek Tenggara. He has done pioneering work on high-density, low-rise housing in Malaysia, where he maintains an office in partnership with Malaysians, and has also been involved in research and teaching. Currently he is undertaking a teaching programme on Fundamental Forms and their Relationships in the School of Architecture at the National University of Singapore. In the Autumn of 1986 he was a Visiting Scholar in the Aga Khan Program at the Massachusetts Institute of Technology. He has written numerous papers on the theory of planning, architecture, and the future of the city. During 1985-87 he was Chairman of the Professional Development Committee of the Singapore Institute of Architects. In 1987 he was appointed by the Minister of Community Development to chair a task force on the long-term development of Singapore's National Museum.

THAM SEONG CHEE is currently Acting Head and an Associate Professor in the Department of Malay Studies at the National University of Singapore. His research interests include the sociology of development, the sociology of education, ethnic relations, religion and modernization, the family in social change, the sociology of language, the sociology of literature, and political sociology. Among his major publications are *Malays and Modernization: A Sociological Interpretation* (Singapore: Singapore University Press, 1977; 2nd ed., 1983); *Language and Cognition: An Analysis of the Thought and Culture of the Malays* (Singapore: Chopmen Enterprise, 1977); *Religion and Modernization: A Study of Changing Rituals among Singapore's Chinese, Malays and Indians* (Tokyo: Centre for East Asian Cultural Studies, 1984; and Singapore: Graham Brash, 1985); and *Social Science Research in Malaysia* (Tokyo: Institute of Development Economics, 1980, and Singapore: Graham Brash, 1981). In addition he has also edited a volume entitled *Essays on Literature and Society in Southeast Asia: Political and Sociological Perspectives* (Singapore: Singapore University Press, 1981). His most recently completed work is entitled *Social Change and Cognitive Development: A Study of the Evolution of Malay* (forthcoming). Professor Tham serves in various international academic and research organizations: for example, as Vice-Chairman of the UNESCO Advisory Committee on the Study of Southeast Asian Cultures; Member, Board of Trustees of the Institute of Southeast Asian Studies; Member, Regional Advisory Board of the journal, *SOJOURN: Social Issues in Southeast Asia*, and Board member of the Biopolitics International Organization. He is also Chairman of the National University of Singapore Multi-Disciplinary Research Committee on the Family in Singapore.

EDWIN THUMBOO is Professor of English and Dean of the Faculty of Arts and Social Sciences at the National University of Singapore. He has edited two anthologies of poetry, published three volumes of his own, and written articles on Shakespeare, Donne, Wordsworth, Forster, Conrad, and various Commonwealth writers.

ROBERT O. TILMAN was Professor of Political Science and (until July 1984) Dean of the School of Humanities and Social Sciences at North Carolina State University. He was author and editor of, and contributor to, numerous publications dealing with international politics, international relations, and foreign-policy issues in the ASEAN area. His publications include *Bureaucratic Transition in Malaya* (Durham, NC: Duke University Press, and London: Cambridge University Press, 1964); (ed.) *Man, State,*

and *Society in Contemporary Southeast Asia* (New York: Praeger Publishers, 1969); and most recently *Southeast Asia and the Enemy Beyond: ASEAN Perceptions of External Threats* (Boulder, Colorado: Westview Press, 1987). Professor Tilman died at his home in the United States on 23 August 1987.

N. VARAPRASAD is Deputy Principal (Academic) at the Singapore Polytechnic. He obtained his Bachelor's and Master's degrees in Engineering from New Zealand before acquiring his doctorate in Transport Studies from the United Kingdom. He taught at the National University of Singapore (1972-85) before joining the Polytechnic. He has published a number of papers on the applications of systems methodology to the study of transport and land-use issues.

RAJ VASIL was educated at universities in India, the United States, and the Netherlands. After teaching in India, he joined the Victoria University of Wellington, New Zealand in 1967, where he is at present the Chairman of the Department of Political Science. He has been a Visiting Professor at the University of the South Pacific; the University of the West Indies, St. Augustine, Trinidad; the University of California, Santa Cruz; and the National University of Singapore.

Dr Vasil is a recognized specialist in the politics of multi-racial societies in the Third World and in the politics of Malaysia and Singapore. His major publications include *Politics in a Plural Society: A Study of Non-Communal Political Parties in Malaysia* (Kuala Lumpur: Oxford University Press, 1971); *Politics in Bi-Racial Societies: The Third World Experience* (New Delhi: Vikas Publishing House, 1984), and *Governing Singapore* (Singapore: Eastern Universities Press, 1984; rev. ed., Singapore: Times Books International, 1988).

EZRA F. VOGEL is director of the Program on United States-Japan Relations at the Harvard Center for International Affairs. He has written extensively on China and Japan. His publications include *Canton under Communism: Programs and Politics in a Provincial Capital, 1949-1968* (Cambridge, Mass.: Harvard University Press, 1969); *Social Change: The Case of Rural China* (Boston: Allyn and Bacon, 1971); *Comeback: Capturing the Future for America* (New York: Simon and Schuster, 1985); and *Japan as Number One: Revisited* (Singapore: Institute of Southeast Asian Studies, 1986).

WANG GUNGWU was educated in Malaysia before acquiring his Ph.D. from the University of London's School of Oriental and African Studies. He is at present the Vice-Chancellor of the University of Hong Kong and Emeritus Professor of Far Eastern History, having formerly been Professor of History at the University of Malaya and the Director of the Research School of Pacific Studies at the Australian National University in Canberra. Professor Wang has published several books and many articles and essays in the field of Chinese and Southeast Asian History, including *The Nanhai Trade: A Study of the Early History of Chinese Trade in the South China Sea* (Kuala Lumpur: Malayan Branch of the Royal Asiatic Society, 1958); *China and the World Since 1949: The Impact of Independence, Modernity, and Revolution* (New York: St. Martin's Press, 1977); and *Community and Nation: Essays on Southeast Asia and the Chinese* (Sydney: Allen & Unwin, 1981).

PAUL WHEATLEY received Ph.D. and D. Lit. degrees from the University of London, and is a Fellow of the American Academy of Arts and Sciences and a Corresponding Fellow of the British Academy. He has taught in the Universities of Malaya (Singapore), California (Berkeley), and London (University College London), and is currently the Irving B. Harris Professor of Social Thought in the University of Chicago. His publications include *The Golden Khersonese* (Singapore: University of Malaya Press, 1961); *The Pivot of the Four Quarters* (Edinburgh: University of Edinburgh Press, 1971); (with Thomas See) *From Court to Capital* (Chicago: University of Chicago Press, 1978); *La Città Come Simbolo* (Brèscia: Editrice Morcelliana S.p.A., 1981); and (with Kernial Singh Sandhu, eds.) *Melaka*, 2 vols. (Petaling Jaya, Malaysia: Oxford University Press, 1983).

W.E. WILLMOIT is Professor of Sociology at the University of Canterbury, Christchurch, New Zealand. Born in Chengdu, China, he received his first degrees from McGill University in Sociology and Anthropology, then completed his doctorate, based on research among the Overseas Chinese in Kampuchea (1962-63), at the London School of Economics and Political Science (University of London). He has studied the development of national sentiment in the countries of Southeast Asia, China, Canada, and New Zealand.

ALINE K. WONG is an Associate Professor of Sociology at the National University of Singapore. She was educated at the University of California, Berkeley, where she obtained her Ph.D. in 1970. She specializes in Urban Sociology, Population and Development, and Women's Studies. Among her recent publications are: (with Ng Shui Meng) *Ethnicity and Fertility in Southeast Asia: Comparative Analysis* (Singapore: Institute of Southeast Asian Studies, 1985) and (with Stephen Yeh, eds.) *Housing a Nation: Twenty-five Years of Public Housing in Singapore* (Singapore: Maruzen Asia, 1985). During her sabbaticals she has been affiliated with the Center for Population Studies, Harvard University; St. Antony's College, Oxford University; and the Institute of Southeast Asian Studies, Singapore. Apart from being a full-time academic, she has also been a Member of Parliament in Singapore since 1984.

WONG POH POH, Ph.D. (McGill, 1971), is an Associate Professor in the Department of Geography at the National University of Singapore. He has been engaged in research on the changing physical landscapes and geomorphology of Singapore since the late 1960s. His published papers are mainly on the coastal geomorphology of Singapore, Malaysia, and Barbados, but recently he has extended his research into coastal tourism.

YAP MUI TENG received her B.Soc.Sci. (Honours in Sociology) degree from the University of Singapore in 1975, and her MA in Sociology (specializing in Population Studies) and Ph.D. in Sociology from the University of Hawaii in 1980 and 1985 respectively. She was a Research Fellow at the East-West Population Institute in Honolulu, Hawaii from 1979 to 1987, after serving as a statistician in the Research and Evaluation Unit of the Singapore Family Planning and Population Board from August

1975 to August 1979. Currently she is employed as a statistician in the Population Planning Unit of the Ministry of Health, Singapore.

STEPHEN H.K. YEH, Ph.D., is Professor of Sociology and Population Studies at the University of Hawaii. He has been active in low-income housing research and consultation in East and Southeast Asia for many years. He served as Honorary Head of, and Honorary Consultant to, the Systems and Research Department of the Singapore Housing and Development Board from 1969 to 1986. Among his numerous publications are *Public Housing in Singapore: A Multi-Disciplinary Study* (Singapore: Singapore University Press, 1975) and (with Aline K. Wong, eds.) *Housing a Nation: 25 Years of Public Housing in Singapore* (Singapore: Maruzen Asia, 1985).
