## CONFERENCES, WORKSHOPS, AND SEMINARS

### I Domestic Economic Order in ASEAN: A Critical Appraisal

The ninth annual conference of the Federation of ASEAN Economic Associations was held from 12–14 November 1984 in Kuala Lumpur. Some sixty economists from the ASEAN countries (excluding Brunei) and a number of observers from other countries attended. The conference was opened by YAB Datuk Musa Hitam, Deputy Prime Minister, Malaysia, who stressed the need for intra-ASEAN investment to counteract reduced investment flows in the current period of slower growth of the global economy.

The conference discussed papers on the internal structures of the ASEAN economies (Tan Tat Wai, Malaysia); the short-term performance and prospects of the ASEAN economies (Jesus Estanislao and Vaughn Montes, Philippines); ASEAN industrialization (Fong Chan Onn, Malaysia); the internal structural adjustments in ASEAN in the manufacturing sector (Amado Castro, Philippines); interregional input-output analysis of ASEAN-U.S. and ASEAN-Japan interrelations (Iwan Aziz, Indonesia); fiscal and monetary policies in ASEAN (Mukul G. Asher and Amina Tyabji, Singapore); human resource management in ASEAN (Nipon Paopongsakorn; Thailand); and the role of the service sector in ASEAN (Koh Ai Tee, Singapore). On the last day of the conference the long-term perspectives of ASEAN were discussed on the basis of a paper by Agustin Kintanar, Philippines/Institute of Southeast Asian Studies.

The tenth conference of the Federation of ASEAN Economic Associations will be held in Singapore in November 1985 and is expected to focus on social security systems in ASEAN.

## **II** ASEAN Symposium on Trade Facilitation

A three-day ASEAN symposium on trade facilitation was held in Kuala Lumpur from 11 to 13 December 1984. The symposium was jointly organized by the Malaysian Government (on behalf of the governments of the ASEAN countries) and the National Chamber of Commerce and Industry (on behalf of the ASEAN private sector) and sponsored by the United Nations Development Programme.

### III Workshop on ASEAN Small and Medium Business Improvement: Financial Factors

The Workshop was held in Singapore on 22–23 March 1985. The twenty-nine participants included representatives from the participating country research teams (all ASEAN countries except Brunei) as well as public and private sector officials from the participating countries active in small and medium business financing. Professor K.S. Sandhu, Director of ISEAS, chaired the two-day proceedings.

The opening session featured a presentation by Dr Narongchai Akrasanee, who will be writing an integrative overview paper incorporating the individual country research findings as well as the findings of the Workshop. As with all sessions, his presentation was followed by a general discussion.

In the succeeding sessions, the respective country studies were presented for discussion

and comment. The final session was a panel discussion in which each country team leader was given the opportunity to reassess his original presentation in the light of the findings of the Workshop. More importantly, this gave the participants the opportunity to reach consensus on common findings and conclusions.

The Workshop was intended as a forum for feedback on the research findings of practising experts from the region. Judging from the enthusiastic participation of researchers and practitioners alike, it was felt that this aim had been amply satisfied.

The five country-papers and the overview paper are currently being revised in the light of the feedback from the Worshop. These will then be edited for publication.

### IV ASEAN-U.S. Economic Relations

In the framework of its series of projects on ASEAN external relations, the ASEAN Economic Research Unit of the Institute of Southeast Asian Studies organized a workshop on ASEAN-U.S. Economic Relations in Singapore, 22–24 April 1985. The workshop was attended by twenty-five scholars from ASEAN countries and the United States to discuss the following topics:

- 4. The Impact of U.S. Policy Mix on the ASEAN Economies (Paper presented by Woo Wing Thye, Brookings Institution, U.S.A.);
- 5. Transfer of Technology to the ASEAN Region by U.S. Transnational Corporations (Paper presented by Charles W. Lindsey, U.S.A.);
- Complementation of U.S. Investments in ASEAN (Paper presented by Bienvenido Rola and Marjorie L. Suriyamongkol, ESCAP/UNCTC Joint Unit on TNCs);
- 7. ASEAN Manufactured Exports to the United States. (Paper presented by Chia Siow Yue, Singapore);
- U.S. Exports of Goods and Services to ASEAN and their Competitiveness visà-vis Japanese and EEC Goods (Paper

presented by Eric Rasmussen, Chemical Bank, Tokyo).
