IV. Fourth ASEAN Energy Conference on Energy Technology

Organized by the Science Council Singapore on behalf of the ASEAN Working Group on Non-Conventional Energy Research, this conference was sponsored by the ASEAN-Australia Economic Co-operation Programme and ASEAN Committee on Science and Technology. Held from 5 to 7 November 1987 in Singapore, it was one in the series of meetings organized for the purpose of disseminating information on ASEAN energy research co-operation.
