**Abdul Aziz Bari** is a Professor of Law, International Islamic University Malaysia. He has published widely on various aspects of Malaysian constitution and public law. To date he has published eight books including *Malaysian Constitution: A Critical Introduction* and *Cabinet Principles in Malaysia: The Law and Practice*. He was formerly head of the public law department and deputy dean (research and development) in the university. He is also the editor of *IUM Law Journal*.

Associate Professor **Teofilo C. Daquila** teaches economics in the Southeast Asian Studies Programme at the National University of Singapore. He has had teaching and research appointments at Korea University, George Washington University, Chulalongkorn University, University of Melbourne, Deakin University, Australian National University, National University of Singapore, El Colegio de Mexico, Nordic Institute for Asian Studies, University of Munich, and the Institute of Southeast Asian Studies. His publications include *The Economies of Southeast Asia: Indonesia, Malaysia, Philippines, Singapore and Thailand* (New York, 2005), *Regionalism and Multilateralism: ASEAN in the Global Economy* (Manila, 2005), and *The Transformation of Southeast Asian Economies* (New York, 2007). A substantial part of this chapter was completed at Korea University's Graduate School of International Studies in May/June 2004.

**N. Ganesan** is Professor of Southeast Asian politics at the Hiroshima Peace Institute in Japan. His most recent major works are *Realism and Interdependence in Singapore's Foreign Policy* (London: Routledge, 2005, 2007 reprint) and *Myanmar: State, Society and Ethnicity*, edited with Kyaw Yin Hlaing (Singapore: Institute of Southeast Asian Studies, 2007).

**Kamarulnizam Abdullah** is Associate Professor and Head of Strategic Studies and International Relations programme at the School of History, Politics, and Strategic Studies, Universiti Kebangsaan Malaysia. His main research area is on political violence, religious militancy, and national security. His works have been published in books, book chapters and journal articles, including *The Politics of Islam in Contemporary Malaysia* (UKM Publication, 2003);

**Albert Lau** is Head and Associate Professor at the Department of History, National University of Singapore, and Chairman of the Editorial Board of the *Journal of Southeast Asian Studies*. He is the author of numerous books, including *The Malayan Union Controversy 1942–1948* (Singapore: Oxford University Press, 1991), and *A Moment of Anguish: Singapore in Malaysia and the Politics of Disengagement* (Singapore: Times Academic Press, 1998).

**Lee Poh Onn** is Fellow, Institute of Southeast Asian Studies. He specializes on research related to political economy of the environment and natural resources in Southeast Asia using New Institutional Economics. His recent publications include a co-edited volume with Aris Ananta on *Aceh: A New Dawn* (Singapore: Institute of Southeast Asian Studies, 2007).

**Linda Low** is Head, Strategic Planning, Department of Planning and Economy, Abu Dhabi, United Arab Emirates and Adjunct Professor, United Arab Emirates University, College of Business and Economics. Her academic areas of specialization include public sector economics and public policy, public enterprises and privatization, social security and retirement, health economics, human resources development and manpower policies, international trade and regionalism including free trade agreements, international political economy, development economics and macroeconomic public policies related to economies in Asia-Pacific, the Association of Southeast Asian Nations (ASEAN) and the Middle East. In policy-related areas, her specialization is in strategic planning for economic development and growth which *inter alia* includes planning for manpower, education, human resources development (HRD) and continuous educational and training for employability. Related to HRD, other policy areas in health and housing for socio-economic welfare are part of her policy work. **Mahani Zainal Abidin** is Director General of the Institute of Strategic and International Studies, Malaysia. She obtained a Ph.D. (development economics) from the University of London in 1992. Her research interests are in the areas of industrial policy, international trade and regional groupings. She was Professor in the Department of Applied Economics at the Faculty of Economics and Administration, University of Malaya. In 1998, Dr Mahani was appointed a member of the Working Group for the National Economic Action Council, a body established by the Malaysian Government to formulate measures to initiate recovery from the economic and financial crisis. Dr Mahani was Head, Special Consultancy Team on Globalization of the National Economic Action Council from 2001 to 2005. She was appointed Deputy Director General, Department of Higher Education, Ministry of Higher Education, Malaysia from 2005 to 2007. She also served as Deputy Chairman of the Malaysian National Accreditation Board (2003–2007).

Prof. Dato' **Mohamad Abu Bakar** was until recently Visiting Professor in Southeast Asian Studies at Ohio University, USA. He is now with the Department of International and Strategic Studies, University of Malaya, where he teaches contemporary Islam, Malaysia's foreign policy, and Malay politics.

**Ooi Keat Gin** is Associate Professor and Coordinator of the Asia-Pacific Research Unit (APRU) in the School of Humanities, Universiti Sains Malaysia, and chief editor of the *International Journal of Asia-Pacific Studies* (IJAPS). He specializes in the modern history of Southeast Asia with particular focus on Borneo. Past publications include *World beyond the Rivers* (Hull, 1996), *Of Free Trade and Native Interests* (Oxford, 1997), *Japanese Empire in the Tropics*, 2 vols. (Ohio, 1998), *Rising Sun over Borneo* (Macmillan/St Martin's, 1999), *Malaysia* (ABC-Clio, 1999), *From Colonial Outpost to Cosmopolitan Centre* (Academia Sinica, 2002), and *Traumas and Heroism* (Opus, 2009). He edited the award-winning *Southeast Asia: A Historical Encyclopedia, from Angkor Wat to East Timor*, 3 vols. (ABC-Clio, 2004). Amongst forthcoming works are: *Themes for Thought on Southeast Asia: A Festschrift to Professor Nicholas Tarling on the Occasion of His 75th Birthday* (Special Issue, *New Zealand Journal of Asian Studies*), *Historical Dictionary of Malaysia* (Scarecrow), and *The Japanese Occupation of Borneo, 1941–1945* (Routledge).

**Takashi Shiraishi** is Vice-President and Professor at the National Graduate Institute for Policy Studies (GRIPS), and President of the Institute of Developing Economies (IDE), Japan External Trade Organization (JETRO)

in Tokyo. He is the author of numerous books, including *An Age in Motion: Popular Radicalism in Java 1912–1926* (Cornell, 1990; Ohira Asia Pacific Award), *Indonesia Kokka to Seiji* (Indonesia: Government and Politics, Libroport, 1991; Suntory Academic Award), and *Umi no Teikoku* (Maritime Empires: The Making of a Region, Chuokoron, 2000, Yomiuri-Yoshino Sakuzo Award). He was recently awarded the Medal with Purple Ribbon by the Japanese government for his contributions to Southeast Asian Studies.

**Anthony John Stockwell** is Emeritus Professor of Modern History at Royal Holloway, University of London. He was Professor of Imperial and Commonwealth History, Royal Holloway, University of London (1996–2003) and Head of the History Department (1997–2002). He previously served as Dean of International Students and Dean of the Faculties of Arts and Music. He has been a member of the Council of the Royal Asiatic Society since the 1990s and was President in 2000–2003, Vice-President in 2003–2006 and re-elected President in 2006. He is currently Chair of the Friends of The National Archives (UK). A founder-member of the project committee of the British Documents on End of Empire, he has edited volumes on *Malaya* (HMSO, 1995) and *Malaysia* (TSO, 2004). He was joint editor of the *Journal of Imperial and Commonwealth History* from 1989 to 2007.

**Carlyle A. Thayer** is Professor of Politics, School of Humanities and Social Sciences, University College, The University of New South Wales at the Australian Defence Force Academy in Canberra where he specializes in Southeast Asian security issues. Thayer was given leave “in the national interest” to accept appointment as Professor of Southeast Asian Studies at the Asia-Pacific Center for Security Studies in Honolulu (1999–2001). On return to Australia he was seconded to Deakin University to serve as their On Site Academic Co-ordinator at the Centre of Defence and Strategic Studies at the Australian Defence College (2002–2004). The following year he was appointed C.V. Starr Distinguished Visiting Professor at the School of Advanced International Studies, Johns Hopkins University in Washington, D.C. He then took responsibility for regional security studies at the Australian Command and Staff College (2006–2007). In 2008, he was appointed the Inaugural Frances M. and Stephen H. Fuller Distinguished Visiting Professor of Southeast Asian Studies at Ohio University.
