These problems pose massive challenges to Indonesian governments as they try to provide clean water, public transport, housing, garbage disposal and other services to urban dwellers.







With regard to Chinese education, prior to the rise of China, Chinese schools were catered to mainly overseas Chinese children. Non- Chinese seldom received Chinese education. However, the rise of China and the export of Confucius Institutes (CIs) changed the landscape as CIs are meant for the non-Chinese population as well. China's educational soft power penetrated the larger non-Chinese community, making Chinese soft power more effective. Chinese popular culture has also infiltrated the non-Chinese population.





Various chapters in this book show that rising China's soft power in Southeast Asia has grown quite significantly, particularly in terms of the Chinese language and Chinese popular culture. Nevertheless, its popularity still lags behind American soft power. The Chinese language is still not as popular as the English language. The same could also be said for Chinese popular culture. The growth of China's soft power faces tremendous challenges in the Southeast Asian region. Its further growth would depend on China's continuous economic power and cordial relations with the Southeast Asian countries.


Malaysian Chinese (Mahua) literature is marginalized on several fronts. In the international literary space, which privileges the West, Malaysia is considered remote. The institutions of modern Chinese literature favor mainland China, Taiwan, and Hong Kong. Within Malaysia, only texts in Malay, the national language, are considered national literature by the state. However, Mahua authors have produced creative and thought-provoking works that have won growing critical recognition, showing Malaysia to be a laboratory for imaginative Chinese writing.

Highlighting Mahua literature's distinctive mode of evolution, Cheow Thia Chan demonstrates that authors' grasp of their marginality in the world-Chinese

literary space has been the impetus for—rather than a barrier to—aesthetic inventiveness. He foregrounds the historical links between Malaysia and other Chinese-speaking regions, tracing how Mahua writers engage in the "worlding" of modern Chinese literature by navigating interconnected literary spaces. Focusing on writers including Lin Cantian, Han Suyin, Wang Anyi, and Li Yongping, whose works craft signature literary languages, Chan examines narrative representations of multilingual social realities and authorial reflections on colonial Malaya or independent Malaysia as valid literary terrain.

Delineating the inter-Asian "crossings" of Mahua literary production—physical journeys, interactions among social groups, and mindset shifts—from the 1930s to the 2000s, he contends that new perspectives from the periphery are essential to understanding the globalization of modern Chinese literature. By emphasizing the inner diversities and connected histories in the margins, Malaysian Crossings offers a powerful argument for remapping global Chinese literature and world literature.







This volume is a collection of articles that examines how the COVID-19 pandemic affected and intersected with various Southeast Asian contexts in the broad areas of migration, education and demographic policy. At the height of the pandemic from 2020 to 2022, the resulting restrictions to international travel, ensuing

nationwide lockdowns and eventual economic crises formed part of what many commentators referred to as a "new normal". Apart from being a global health crisis, the pandemic disrupted and transformed the experience of everyday life at all levels of society, where many of its effects are now likely irreversible. In particular, the impact of the pandemic certainly affected the most vulnerable individuals and communities throughout the region, especially when taking into account the demographic transformations in countries that are experiencing rapid ageing such as Singapore and Thailand. Examples of the most affected include low-wage migrant workers, the disabled and the children of impoverished families. For many who were already living in a state of precarity, the structural "side-effects" of the pandemic were at times more deadly than the coronavirus itself as it often negatively impacted livelihood, social-emotional ties and overall well-being. At the same time, the "new normal" has further created conditions that raise the likelihood of occupational precarity even for long-term professionals within established fields like education. In other words, few experienced the COVID-19 pandemic without encountering both tangible and intangible challenges, regardless of where one was situated.

Its membership was restricted to graduates of British and European universities, fellows of British or European learned societies and those with "distinguished merit in the opinion of the Society in any branch of knowledge". Its closed-door meetings were an important gathering place for the educated elite of the colony, comprising colonial civil servants, soldiers, missionaries, businessmen, as well as prominent Straits Chinese members. Notable members included the botanist Henry Ridley, the missionary W.G. Shellabear and Straits Chinese reformers like Lim Boon Keng and Tan Teck Soon.

Throughout its years of operation, the Society left behind a collection of papers presented by its members, the vast majority of which conformed to the Society's founding rule that its geographical position should influence its work.

By republishing these papers, *The Straits Philosophical Society & Colonial Elites in Malaya* seeks to contribute to the intellectual history of colonial and post-colonial Malaysia and Singapore, and to expand our understanding of the ways in which colonial thought has shaped governing systems of the past and present.

Timor-Leste in ASEAN: Is It Ready to Join?

After more than a decade of deliberations, ASEAN leaders agreed on 11 November 2022 in principle to admit Timor-Leste as the eleventh member of the regional organization and to grant Timor-Leste observer status to attend all ASEAN meetings. Timor-Leste has demonstrated positive developmental progress, and fact-finding missions across the three ASEAN Community pillars have returned generally optimistic results.

However, an assessment of Timor-Leste's ability to fulfil its commitments and obligations reveals that the country will need to close the gap with the ten existing members on matters such as the ratification and implementation of legally binding agreements and derivative work plans. Creating enforcement mechanisms and finding ways to implement commitments at the local level will be important.

It argues that the Global Development Initiative (GDI), Global Security Initiative (GSI) and Global Civilization Initiative (GCI), which are key pillars of China's proposal to build a community of common destiny for mankind, are driven by Beijing's desire to cultivate authority in the international system.



Analysing the speeches by Chinese leaders, policy documents, media and

analytical discourse in China, along with policy decisions, this study provides an assessment of the Chinese leadership's worldview. It places the launch of GDI, GSI and GCI within this context, before detailing the elements of each initiative and offering a critical analysis.

This study concludes that through GDI, GSI and GCI, the Chinese leadership hopes to shape an external environment that not only ensures regime security but is also favourable to China's development and security interests. In doing so, however, it is reshaping key norms of global governance towards a fundamentally illiberal direction.

Enhancing ASEAN's Role in Critical Mineral Supply Chains

The clean energy transition momentum is gathering pace globally, and in Southeast Asia as well. The transition is dependent on an uninterrupted supply of critical minerals and metals that are essential for the production of low-carbon technologies.

The supply of critical minerals is impeded by several constraints. First is the dominance of a handful of countries in both the upstream and downstream parts of the supply chain. Second is the current geopolitical race to secure supplies leading to greater protectionist behaviours, exhibited through export bans and trade impediments.

This study focuses on four selected critical minerals which are important to the region. Two criteria are used in determining a mineral having high significance: (1) There are significant deposits of it which can be tapped on to bolster Southeast Asia's strategic position in the supply chains; and (2) It is an essential input in industries and sectors of importance in Southeast Asia. The four critical minerals examined in this study are: copper, nickel, bauxite (alumina), and rare earth elements (REEs).





Scrutinizing the DAP's Success in the 2023 Malaysian State Elections

A key question arising from this cooperation between PH and the BN lead party, the United Malays National Organization (UMNO), was the extent to which it would strengthen the appeal of both coalitions, especially among Malay voters.



Using granular polling station and polling stream data for forty-seven seats contested by the PH member Democratic Action Party (DAP), this paper explores the effect of this relationship on voter support. This *Trends in Southeast Asia* finds that, contrary to expectations, DAP actually gained voter support from campaigning with UMNO.



Myanmar's Resistance and the Future of Border Trade: Challenges and Opportunities

Since the start of Operation 1027, Myanmar's resistance groups have gained control over large parts of key overland trade routes and a number of important border crossings, fundamentally changing the realities in the control of border trade.

Despite these losses, the State Administration Council (SAC) retains control-oftrade-related institutions that are vital for accessing an international trading system characterized by state-to-state interactions—giving them significant influence over trade even if they do not control trade routes and border crossings.

International precedents from territories such as Palestine, Transnistria, Abkhazia and South Ossetia show that non-state actors face significant challenges engaging in trade, and are vulnerable to frequent changes in trading arrangements. Perhaps the most important factor shaping trade in these territories is the state of their relationship with either the state of which they are nominally a part, or a neighbouring state.

Why Young Malay Voters in Malaysia Are "Turning Green"

There is an increasing trend among young Malay voters in Malaysia to support the Perikatan Nasional coalition, with a particular emphasis on the Islamist party PAS.

Despite recognition of the weak economy as a significant national concern, young Malay voters continue to place a higher emphasis on Muslim leaders who assert their commitment to safeguarding the rights of Islam in Malaysia.

Consistent with theories on political socialization, the influence of family members significantly affects young Malay voters in Malaysia, particularly due to their limited political awareness of alternative channels like formal schooling.

Young Malay voters acknowledge the significant impact of social media and TikTok, particularly in how these shape the voting patterns of their peers. They nevertheless maintain a perception of their own impartiality in this regard.

Interestingly, the influence of Islamic institutions, with their own educational philosophy, on the political behaviour of Malay youth is minimal, as their political ideas are already shaped by their early experiences.

Malaysia's Responses to Issues Pertaining to Palestine

Malaysia's support for Palestinian independence has always been based on religion. Historically, Malaysia has had warm relations with Palestinian leaders including the Palestine Liberation Organization—during Hussein Onn's and Mahathir Mohamad's administrations—and Hamas since Najib Razak's administration.

However, Malaysia's support is not just based on their affinity to Palestinians as fellow Muslims but is also a matter of domestic politics. Support for Palestine has been used as a political tool for various guarters to prove that they are more Islamic than the other.

Malaysia is now led by Prime Minister Anwar Ibrahim, a former student leader who rose to prominence in the 1970s for his activism on issues regarding the Muslim *ummah*, including Palestinian independence. Over the years, Anwar has demonstrated consistency in his support for Palestinians, and this has especially been the case since the outbreak of Israeli aggression against Gaza which began on 7 October 2023.

Delivering Development, Enforcing Shariah: PAS's Dilemma in Terengganu

Whenever the Islamist party PAS comes to power in Terengganu, its political agenda has been to combine populist-type development programmes with the wish to turn Terengganu into a shariah-compliant state.

Terengganu's state budget is however heavily dependent on the federal government, to the tune of 80–90 per cent. This hinders the state government's policymaking and implementation, especially when the federal government is controlled by its political opponents.

This article argues that the politics of development play a more central role in determining the durability of the PAS state government in Terengganu than it does in neighbouring Kelantan. In other words, PAS cannot simply carry out its Islamic agenda without being complemented by tangible economic progress if it aspires to govern beyond a single term; PAS's loss in the 2004 election after being in power for one term is a prime example of this dynamic.

One reason that the current PAS state government managed to get re-elected in 2022 was the unimpeded flow of oil royalty payments into state coffers since 2018, which allowed the state government to fulfil its campaign promises; PAS's inclusion in the Perikatan Nasional federal government in 2020 further improved the state government's financial standing.

Party of Hardship: The Evolution of Malaysia's Parti Keadilan Rakyat

The People's Justice Party (PKR) may in many ways be synonymous with its largerthan-life leader, Anwar Ibrahim, who, although only president for six of the party's twenty-five years, has always been its de facto leader and adviser. However, PKR is much more than only about Anwar, and this paper traces the evolution of the party independently of Anwar as a person.

PKR's evolution can be broken down into four main periods: 1998–2004 (formative), 2005–13 (golden era), 2014–18 (all-in for power), and 2019–22 (lessons

on restraints). From 1998 to 2022, PKR tended to adopt a big-tent approach (internally and externally), ideological synthesis to find a middle ground, and a loose organization led by a charismatic personality at the top and self-organization at the grassroots.

PKR was born out of a major crisis when Anwar, then deputy prime minister, was sacked in 1998 and subsequently jailed twice in the following two decades. For the most part, the party operated with its figurehead in jail, thus learning how to rely on coalition strengths, working with civil society, mass movements, and political parties to survive and win power.

Understanding Vietnam's Foreign Policy Choices Amid Sino-US Rivalry

Vietnam's foreign policy towards China and the United States (US) involves a delicate process of reconciling and balancing competing perceptions, goals and interests within the country. This leads to foreign policy decisions that may respectively lean towards either China or the US, depending on specific circumstances and issues, while trying to maintain an overall equilibrium between the two powers.

Vietnam's foreign policy adopts the paradigm of "cooperation" and "struggle" in its relations with major powers, and defines "national security" as encompassing both national sovereignty and regime security.

Given the common ideology and imperative of preserving political control of their respective communist parties, China may be a critical partner for Vietnam in terms of regime security but is often an "object of struggle" on national sovereignty. On the other hand, the US is Vietnam's partner in the South China Sea but an "object of struggle" when it comes to regime security.

The Vietnamese public's favourable sentiments towards the US, contrasted with their distrust towards China, pose a challenge for the Communist Party of Vietnam (CPV) in mobilizing public opinion to bolster its legitimacy while preventing any potential threat to its political authority.

Who's Doing What? A Closer Look at Methane Climate Impact and Commitments in Southeast Asia's Energy Sector

Qiu Jiahui

This article draws from a database of asset-level emissions to identify key methaneemitting coal, oil and gas facilities in Southeast Asia while taking stock of the methane commitments of their owners.

Coal mines account for around a third of fossil fuel methane emissions globally, but in Southeast Asia they make up more than half of tracked fossil fuel methane emissions.

Over half of emissions from the coal mining subsector is traced to its top ten emitters, mostly in East Kalimantan, Indonesia; while some coal mines in North Vietnam have high emissions intensities.

Though the global discourse on fossil methane focuses on oil and gas, coal mine methane remains crucial for Southeast Asia due to the region's lack of decisive coal phaseout plans.

As countries begin to tackle coal emissions at the power generation stage, a gap still remains when it comes to coal mining emissions. Methane monitoring and abatement actions are urgently needed for coal mines that will continue to operate, as well as those slated for closure.

ASEAN's response has been the formulation of the ASEAN Guide on AI Governance and Ethics, or the ASEAN AI Guide. This Guide serves more as a "practical guide" for organizations involved in the development and deployment of AI for commercial and non-military or dual-use applications, as opposed to a policy playbook for governments. Though voluntary in application, it does have some positive attributes including laying out the groundwork for regionwide discussions around AI governance and ethics issues, promoting human involvement in AI system management and having an ecosystem approach to policy.

Generational Divides in Understanding Thailand's History Grow Amid Political Polarization

Amid political polarization, knowledge and understanding of Thailand's history have also diverged radically. This divide is especially evident between younger and older generations.

Driving this phenomenon is the growing rejection by students of the traditional history taught in public schools, which in the past had been a means for the Thai state to instil in the young a sense of nationalism, national pride and shared values. Poor

pedagogy that emphasizes memorization, and that discourages discussions and critical thinking, has alienated many from the subject. Education professionals and student activists have also been critical of this development.

Moreover, the democratization of information and the availability of alternative sources of historical knowledge have allowed young people to learn about history in ways that challenge the traditional narratives taught in classrooms. The alternative sources include social media, websites by historians and enthusiasts, as well as books printed by independent publishers.


Myanmar's economic trajectory has shifted across various governmental regimes, transitioning from socialist to democratic systems and from planned to market economy structures.


The economic policies implemented by successive governments often lacked coherence and were characterized by ad hoc measures aimed at short-term solutions rather than addressing underlying issues.

Policymakers since 1989 have endeavoured to guide Myanmar towards a market-oriented economy, characterized by what could be termed the "Burmese/Myanmar Way to Market Economy", which includes significant restrictions and controls.

Both the military-backed Union Solidarity Development Party (USDP) and civilian-led National League for Democracy (NLD) administrations made significant efforts to enhance liberalization and strengthen market economic principles, despite multidimensional challenges including inadequate capacities for policy formulation and over-reliance on past domestic experiences rather than international lessons.

Peatland ecosystems in Southeast Asia are globally important as carbon sinks, rich in terrestrial and aquatic fauna and flora, and important sources of livelihood for local communities. However, agribusiness-driven land-use change and drainage cause peatland degradation and peat fires, which generate "haze" air pollution and lead to significant economic losses and health impacts. Learn from Your Comrades: Understanding Authoritarian Diffusion between Vietnam and China

Nguyen Khac Giang

Since the normalization of relations in 1991, Vietnam and China, two of the five remaining communist regimes, have established a robust framework for mutual learning and cooperation. This collaboration has primarily centred around party governance and cadre training.

Vietnam has actively studied and adopted elements of China's successful model, which combines economic reform with strict political control. This approach has allowed Vietnam to maintain communist rule in the face of increasing global pressure for democratic reforms.

The process of learning from China involves two key dynamics: desirability versus capability, and effectiveness versus appropriateness. While Vietnam desires to achieve the same level of effectiveness as China in certain policy areas, it has been cautious in fully replicating the Chinese model, and shown consideration for its appropriateness to Vietnam's unique circumstances and for China's underlying motivations.

The Rising Role of Chinese Firms in Southeast Asia's Automotive Supply Chain

Chinese firms have become global leaders in the electrification, networking and intelligentization of vehicles. They are globally dominant in minerals extraction and processing and battery production for electric vehicles (EVs) and are becoming internationally competitive in the enabling microelectronics, components and systems.


This report covers the role of Chinese firms in Southeast Asia across five segments of the EV supply chain, namely minerals extraction and processing; battery

manufacturing, energy storage and charging; original equipment manufacturer (OEM) production of complete vehicles; microelectronics design and manufacturing; and research and development activities.

The report focuses on Indonesia, Thailand, Malaysia, Singapore and Vietnam. These are the five ASEAN economies where activities relevant to EV production are concentrated and where Chinese firms are involved in the supply chain.

The report concludes with policy considerations for ASEAN governments. EVs and connected vehicles have become a new front in the technology contest and political tensions between China and the US, with other big players like the European Union now also moving towards measures to shield their automotive sector markets and companies.

Managing State-Federal Relations: Growing Pressure on Malaysia's Madani Administration

Since the Sheraton Move in 2020 which led to the fall of the Malaysian government, many state governments in the federation have held their elections separately from the central government. This has resulted in a dynamic political situation in which coalitions have been formed in different ways at different times in different states.

At present, there are seven states ruled by the Pakatan Harapan–Barisan Nasional (PHBN) grand coalition, while four states are under the Perikatan Nasional (PN) coalition.

States have increasingly demanded greater political and policy autonomy over the last few years, particularly in the area of fiscal revenue-sharing between the federal and state governments.

Progress has been most forthcoming for issues related to the East Malaysian states of Sabah and Sarawak, and the federal government's newly set-up Malaysia Agreement 1963 Implementation Action Council has been meeting regularly.

Contentious state-federal issues remain for states apart from Sabah and Sarawak, to which the federal government has not seriously responded. Limited space exists for formal state-federal negotiations that can result in firm decisions.

Malaysia's Motorcycle Sector: Past and Present Possibilities in an Era of Energy Transition

Malaysia has traditionally adopted an intensive automotive industrialization model and created its own vehicles under national brands. The national car project started with Proton in 1983, and the national motorcycle project with Modenas in 1995.

While policies and scholarship have focused on national car projects, the twowheeler sector has stood in their shadow. Modenas witnessed early growth and

remains a popular brand after Yamaha and Honda; it has however failed to hit export targets, owing to limited technology transfer and the inability to scale.

In recent years, there has been renewed interest in the two-wheeler sector, focusing on phasing out combustion motorcycles in favour of electric two-wheelers (E2Ws). Still nascent, Malaysia's electric two-wheeler (E2W) sector appears to prioritize an extensive model of assembly and distribution rather than the protection of home-grown brands.

ASEAN and Japan share a robust and multifaceted partnership that has evolved over five decades, and that is grounded in mutual respect, trust and shared values. The establishment of the Comprehensive Strategic Partnership in 2023 further solidifies their commitment to advancing cooperation in traditional areas while expanding into emerging domains such as digital transformation and sustainability.

In the security domain, Japan has consistently prioritized ASEAN's centrality in the regional order, even as it aligns with the United States and participates in frameworks

like the Quad. Initiatives such as the Japan-ASEAN Ministerial Initiative for Enhanced Defense Cooperation (JASMINE) and the Overseas Security Assistance (OSA) framework demonstrate Japan's evolving approach, transitioning from traditional capacity-building to a broader focus on enhancing maritime security, conducting joint exercises, and providing non-offensive defence equipment to ASEAN countries.

The partnership's new emphasis on "co-creation" marks a transformative shift through public and private sector collaboration to address pressing socio-economic challenges. By fostering innovation and co-developing solutions in areas like green energy, digital trade, and healthcare, the co-creation model underscores ASEAN and Japan's shared commitment to inclusive and sustainable development.

Autonomy in Sarawak and Sabah: Different Paths and Diverging Outcomes

When Malaysia was formed in 1963, the Borneo states of Sarawak and Sabah were granted special provisions under the Malaysian Agreement 1963 (MA63) to safeguard their autonomy.

However, centralization measures pursued by the federal government over time have eroded these rights, particularly pertaining to education, development spending and revenue sharing.

Despite being on the same island and sharing a history distinct from Peninsular Malaysia, Sarawak and Sabah have evolved very differently in asserting their autonomy. Sarawak has managed to attain a greater degree of self-government, while Sabah has been more influenced by priorities pursued by Peninsular Malaysia.

These varying outcomes are due to three differences between the two states: distinct historical developments in the run-up to independence; varying degrees of political control attained by the parties in power; and different priorities pursued by state leaders.

Online Campaign Narratives in Thailand's 2023 General Election: An Ecosystem Analysis

Surachanee Sriyai

This article explores the intricate dynamics of election-related narratives and ideological shifts that characterized Thailand's 2023 general election during a pivotal moment when the salient issue transcends the economy, encompassing a profound ideological shift that cuts across social cleavages.

Leveraging an original dataset comprising over 2,500 posts disseminated by major parties on Facebook and X (formerly known as Twitter) one month prior to the election to two days afterwards, the findings show that while parties have different posting strategies and a predetermined platform of choice, their campaign narratives can be categorized in general terms.



Although economic and populist policies are the most prevalent campaigning narratives for most parties, the victory of the Move Forward party, gained through highlighting social issues and structural reforms, suggests that promises to address deep-rooted societal issues might have been more appealing to the Thai voters in this election.

Distinct engagement patterns for some types of posts are also observed, alluding that netizens' reactions can be different based on the types of content posted by parties. However, apart from the Move Forward Party's followers, discrediting narratives did not receive much reaction from other parties' followers.
